From The Secretary's Desk

CHANGES IN REGULATIONS—Summarized below are the major changes that have been made in regulations.

a. **PARTICIPATION WITH INDEPENDENT TEAM**—Clarification has been made in this section to indicate that "period of time" means from the time a pupil reports out for a school team until the end of the season. This means that a pupil is free to play with an independent team so long as he has not reported out for his school team, but that when a pupil reports out for the school, he cannot play from then on to the end of the sports season with any one except his school team.

b. **GIRLS BASKETBALL RULES**—The Girls Basketball Rules for Georgia High Schools are covered in a supplement to the boys rules. Questionnaire returns from Superintendents, Principals, Coaches, and Game Officials indicate that the changes that have been made have been overwhelmingly approved.

The only major changes made from the rules which were used in 1950-51 are:

1. Clock will not be stopped on jump balls.
2. Substitutions may be made when the ball is dead.
3. Procedure for free throws and following free throws is same as for boys rules with minor changes.

c. **ELIGIBILITY IN INTERSCHOLASTIC ACTIVITIES**—All high school pupils who represent a school in any interscholastic activities must meet the eligibility requirements of the GHSA.

d. **PAYMENT OF DUES**—Discount is allowed on membership dues paid on or before October 15. The membership year expires on October 1st. Any school engaging in athletic competition after October 1st must have its dues paid in order to be in good stand-

ing. This means that schools playing football should be especially careful to have their dues paid not later than October 1st in order to be in good standing.

e. CROSS COUNTRY—Cross Country has been an event conducted by Class AA schools only. Beginning with the current year this will be an event open to schools of all classifications. Date and place of Cross Country is given in the calendar.

f. SUBSTITUTION OF GAMES IN FOOTBALL—For the current season any schools that are not able to schedule a sufficient number of games in their region and classification in order to qualify for the region championship, may substitute any number of games with schools of the same classification in any region or with any schools of higher classification, provided that the State Secretary is notified of such substitutions not later than September 1.

g. ONE ACT PLAYS—For the current year the plays which will be used in District and State Meets will be tragedies.

h. NUMBER OF GAMES PER WEEK IN BASKETBALL—The rule which has limited a school to not more than one basketball game per week on a night preceding a school day has been eliminated. A school may play as many games per week and on such nights as their own school authorities may direct, provided that the total number of games played for the season is not more than thirty.

i. TROPHIES IN LITERARY AND TRACK—The awarding of a trophy to the high point school in the winning region or district in the State Meets has been eliminated. Beginning with the current year a trophy will be awarded to the school which places 1st, 2nd, 3rd, and 4th in total points in its respective classification in the State Meets.

j. VOCAL CONTESTS—In all of the Vocal music contests in District, Region, and State Meets, the time limit has been increased two minutes and the number of selections limited to two.

k. QUARTET—A change has been made in the Quartet contest. The contest will be a MALE Quartet. Mixed quartets will not be permitted.

l. TYPING—Typing contests have been changed to provide that there will be two separate contests—one for boys and one for girls.

m. SHORTHAND—The shorthand contest for the past several years has been judged on the transcription alone and errors in typing have been disregarded in scoring the contest. The contest this year will be judged on the finished product which will include both accuracy of the transcribed material and accuracy in typing that material.

n. SCHOOL PASSES—This section has been slightly changed to make clear that school passes are issued only to administrative personnel and to members of the athletic coaching staff. School passes will be issued directly to the individual school based on the information sent in on the information sheet to the State Office. School passes are not issued to band leaders, scorers, timers, bus drivers, chaperons, etc. Passes for these are a matter between the schools concerned in individual games. School passes are good to all school contests and are restricted to administrative and athletic coaching personnel.

o. DEBATE—Please note in the section on debate that there have been changes providing for a score sheet for the judges to use in reaching a decision, and that there has also been a change providing that in a debate the vote of each judge shall count one point with no point being given for the school winning the decision. A further change has been made which will permit a district or a region to group the competing schools in a circle or circles and to hold all debates at the same location if the district or region so sees fit.

p. MIGRATORY RULE—Special attention is called to the changes that have been made in the migratory rule. Each year a number of questions arise in regards to the migratory rule. Below are given some general interpretations of the present migratory rule:

1. Permits a pupil upon completion of the 8th grade to go unrestricted by GHSA rules.
2. Permits a pupil to change schools if his parents change their residence from one school service area to another.
3. Permits a pupil upon completion of the 9th grade in a school which offers 9 grades of work only, to transfer to the Senior high school to which these pupils normally go.
4. Permits a pupil to change schools when such change is brought about by a consolidation of schools.
5. In a situation where a pupil has a choice of schools to attend after completion of elementary or junior high school, permits that pupil to make such a choice but does not permit that pupil to choose again.
6. In a situation where an individual pupil is transferred by a Board of Education, such pupil would not be eligible until completion of the residence requirement of a full calendar year.
7. Requires any migrant pupil to be in attendance for a full calendar year.

8. Applies same transfer rule to pupil who transfers to or from public and/or private schools.

Also there has been a provision made for special hardship cases. A special committee has been set up to consider special cases and this committee has been given authority to waive the migratory rule and to declare a pupil eligible in any individual case when it is shown that the conditions which brought about the change of schools were beyond the control of the school, the student, and/or his parents, and such that none of them could reasonably have been expected to comply with the rule the violation of which is involved. Ignorance of the rule on the part of any or all of them shall not be considered sufficient cause for setting aside its effects.

q. DATE OF LITERARY EVENTS—Action was taken by the State Executive Committee to provide that in District and Regional Literary Contests that in all events in which subjects or tests are required, that such events must be all on the same date in all classifications. All Spelling contests will be held on April 2, 1952. Contests in the following events must be held on April 11, 1952: Typing, Shorthand, Essay, Home Economics, and Reading.

GAME OFFICIALS—One of the problems that has faced the high schools is developing more trained officials to handle the various sports. A tremendous amount of progress has been made in this field. A great contribution can be made to the program if the school officials, Superintendents, Principals, Athletic Directors, and Coaches, will endeavor to enlist men in the field of officiating. This is especially essential in basketball where the need for more trained officials is essential. There are in each community persons with athletic background who are interested in athletics and who will be willing to officiate; there are a number who are already doing this. If the school officials will give the program a boost, it will contribute much to the advancement of the program. Your State Office will provide rules materials for all sports—rule books, case books, handbooks, meeting folders, rules examinations, rules films, and rule clinics for officials. The assistance of school men is needed to:

1. Interest men in officiating.
2. Have those men in your community who are interested in officiating contact the state office so that they can receive information as to location of officials' organizations, dates and places of clinics, and other rules information.

GEORGIA ATHLETIC BENEFIT PLAN—The Georgia Athletic Benefit Plan is still in operation. Last year a record number of athletes, both boys and girls, were given this protection at a very

low cost. Under this plan coverage can be obtained for athletic injuries which occur in games or in practice. The program has been expanded to include hospitalization, special medical services, and other items to improve the coverage. Coverage can be obtained in all sports or in individual sports. For full details write to the State Office.

DEADLINE DATES—Under the announcements you will find the calendar of events for the coming year. In some cases there are certain deadlines that must be met in various events. District and/or Regions must adhere to these deadlines. Failure to do so may disqualify an entry from a district or region.

ELIGIBILITY REPORTS—Attention is called to the fact that eligibility reports must be filed with the State Office at least **TEN DAYS** prior to the first game or contest in any sport. Eligibility reports consist of **ORIGINAL** and **TWO CARBONS** of Eligibility Certificate, Form E-2, and an Individual Sheet for each individual for whom no previous individual sheet has been filed by the school. The State Secretary has been instructed to enforce this strictly and to return to any school its eligibility report which is not in proper form. After your eligibility report has been checked in the state office one of the carbons certified under seal will be returned to the school.*

FOOTBALL—Attention is called to an important change in the football rule book. All football fields must be enclosed by some type of barrier, fence, etc., at least five yards back from all of the boundary lines of the playing field. In addition, there shall be a line marked parallel to each side line at a distance of not less than two yards extending from one thirty yard line to the other thirty yard line. Coaches, players, and all others occupying the team bench must stay within this restraining area during a game. Details in regards to this rule can be obtained from the diagram on Page 4 of the football rule book.

Attention is also directed to the football section in this bulletin. You will find some special changes which will become effective with the football season of 1952 in accordance with notice as given a year ago.

RE-ORGANIZATION REPORT—At the final meeting of the State Executive Committee on June 2, 1951, the report of the re-organization committee was adopted unanimously to become effective in the school year 1952-53. A few minor changes were made in this report and one major change.

The major change made was to provide that Class C would be all schools under 150 Adjusted ADA and that Class B would be all schools from 150 to 300 in Adjusted ADA.

Each school was provided with a copy of the report this past Spring. During this Fall, based on the ADA figures for 1950-51 school year, tentative grouping of the schools in the various classifications by regions will be made. A complete copy of the entire report with the distribution of the schools will be mailed to each school. This will provide opportunity for discussion of any points, suggestions for any changes, and any special requests to move a school from one region to another or from one classification to another in order to correct any errors which may have been made or in order to make some adjustments which might be better for the operation of the entire program. Changing over to a regional plan of operation instead of a plan of district operation is a far reaching change and the cooperation of each school will be needed in order that objectionable points may be eliminated.

Constitution

ARTICLE I—Name of the Organization

This organization shall be known as the Georgia High School Association.

ARTICLE II—Object of the Organization

The object of this organization shall be promotion of education in Georgia from a mental, physical and moral viewpoint to promote the study of public speaking, to standardize and encourage athletics, and to promote appreciation for music, home making and other cultural arts through Districts and State Contests.

ARTICLE III—Membership

Sec. 1. Schools Eligible for Membership—The Membership of the Georgia High School Association shall consist only of white schools that are accredited by the Georgia Accrediting Commission.

Sec. 2. Grouping of Membership by Size—The Membership of the Association shall be divided into three groups, as follows:

Class AA. Composed of eligible private boarding schools, and eligible high schools with an adjusted **A. D. A. of 650 or more.**

Class B. Composed of eligible high schools with an adjusted **A. D. A. of between 125 and 650.**

Class C. Composed of eligible high schools with an adjusted **A. D. A. of less than 125.**

NOTE: The above membership classifications are for the purpose of representation on the State Executive Committee. Competition will be conducted as follows:

Class AA: All eligible private boarding schools, and all eligible high schools with an adjusted A. D. A. of 650 or more. Schools will be grouped by regions.

Class A: All eligible high schools with an adjusted A. D. A. from 300 to 650. Schools will be grouped by regions.

Class B: For football, all eligible high schools with an adjusted A. D. A. from 200 to 300 with schools being grouped by regions.

For all other athletics and literary, all eligible high schools with an adjusted A. D. A. from 125 to 300 with schools being grouped by districts.

Class C: Football, all eligible high schools with an adjusted A. D. A. under 200, with schools being grouped by regions.

For all other athletics and literary, all eligible high schools with an Adjusted A. D. A. under 125 with schools being grouped by districts.

Sec. 3. GROUPING HOW DETERMINED—The classification of schools into various groups shall be based on the Average Daily Attendance (A. D. A.) secured from the State Department of Education of July 1st annual report. The A. D. A. of July 1st shall be used as a basis to determine the classification of a school for the following school year. In case of a consolidation the A. D. A. of the schools consolidated shall be combined to determine the classification. The adjusted A. D. A. shall be calculated as follows:

- a. The four-year school shall be as a base and for a three year high school $\frac{1}{3}$ shall be added to the A. D. A. to determine classification figure.
- b. The double sex school (co-ed) shall be used as a base, and for a single sex school the A. D. A. shall be doubled to determine classification figure.

Sec. 4. GROUPING OF MEMBERSHIP BY DISTRICTS—All schools shall be members of a district organization in the Congressional District in which they are located, with the exception of the Class AA schools which form the District-at-Large.

Sec. 5. COLLEGES—Junior Colleges and preparatory departments of colleges are ineligible for membership in this Association.

Sec. 6. JUNIOR HIGH SCHOOLS—Junior High Schools are ineligible for membership in this Association.

Sec. 7. TRANSFERS FROM DISTRICT—Any eligible school

which is located near the border of a district and because of its location wishes to be transferred to membership in a neighboring district, may do so on consent of the District Committee from both districts and the state president, provided no rules are violated otherwise, and provided the transfer of membership is made before October 1st.

Sec. 8. MEMBERSHIP IN ANOTHER ASSOCIATION—A school is ineligible for membership in the Georgia High School Association if it is or becomes a member of any association whose Constitution and/or By-Laws conflict with those of the Georgia High School Association.

ARTICLE IV—How Governed

Sec. 1. STATE OFFICERS.—The State Officers of this Association shall consist of a President, a first Vice-President, a second Vice-President, and an Executive Secretary-Treasurer. The officers and one member of the faculty where the State Meet is held and the Director of State School Supervision shall be ex-officio members of the State Committee and shall have the right to vote on all matters pertaining to the operation of the Association. These with two members elected by each congressional district of the State and four members elected by the District-at-Large (one from each region of Class AA) shall constitute the State Executive Committee.

Sec. 1a. BOARD OF TRUSTEES.—Said Georgia High School Association shall have a Board of Trustees (four in number) consisting of the four persons holding the following State offices of said Association to wit: President, first Vice-President, second Vice-President, and Executive Secretary-Treasurer, and their respective successors in office. Said Board of Trustees shall receive and hold title to all real and personal property of said Association, in trust for the benefit of said Association and shall have general custody and administration of such property with power and authority to lease, sell and convey said property of said Association; provided, however, said Board of Trustees shall not sell or convey any real property so held by them in trust for said Association without first being authorized to do so by a majority vote of the State Executive Committee of said Association at a meeting duly called for such purpose.

Sec. 2. STATE APPEAL BOARD—The State Appeal Board shall be composed of five members elected by the State Executive Committee. The members of this board shall be selected from the various classifications of schools with representation in proportion to the number of schools in each class. The term of each member of the State Appeal Board shall be for three years and terms shall be so staggered that not more than two members' terms will expire in the same year. (Exceptions—in setting up the original State Ap-

peal Board one member shall have a term of one year; two members shall have a term of two years; and two members shall have a term of three years.)

Sec. 3. DISTRICT OFFICERS.

(a) Each district except the District-at-Large shall elect a President, a Vice-President, a Secretary-Treasurer, and three other committeemen who shall be from Class B and Class C in proportion to the number of member schools from each class, no two shall be from the same school. These officers shall compose the Executive Committee in their district.

(b) The District-at-Large shall elect a President, a Vice-President, and four other committeemen (one from each region) who shall compose the Executive Committee in their district. This committee shall designate one member from their committee to act as recording Secretary and Treasurer. The State Secretary shall act as Secretary for the District-at-Large.

Sec. 4 DUTIES OF OFFICERS. The duties of the various officers and committees shall be those usually devolving upon such officers and committees. It is specifically the duty of the State Executive Committee and the District Committee to seek at all times to educate the school officials under their jurisdiction concerning the Constitution and By-Laws of this Association and at the same time to check vigorously any practice or violation of the rules by exercising the full penalty for such violations if it seems necessary.

Sec. 5. ELECTION OF OFFICERS.

(a) A President, a first Vice-President and a second Vice-President shall be elected as State Association officers at the annual meeting of the Georgia High School Association each year. The election and term of office of the Executive Secretary-Treasurer shall be for a term of one to five years in the discretion of the State Executive Committee, and the President and the Vice-Presidents shall be authorized to execute a contract in the name of and for the State Executive Committee of the Association. Only members of the State Committee shall be entitled to vote in elections. Should the President at any time become disqualified by death, resignation or otherwise the first Vice-President shall assume the office immediately and shall act as President until the next annual election.

(b) A President, a Vice-President, and a Secretary-Treasurer and three district committeemen shall be elected as officers for each district at any Spring Meeting. Each member school shall have only one vote.

(c) State Executive Committeemen from each district shall be

elected for terms of three years at any Spring Meeting when there is a vacancy to be filled. Terms of the members of the State Executive Committee shall be so arranged or staggered that the terms of approximately one-third of the total number of members shall expire each year. Each district except the District-at-Large shall elect one member from B schools and one member from C schools of the respective district. Each member school shall have only one vote. In any district in which the total number of schools in either group is less than 15% of the total membership of the district, it shall not be required that the two members come from different groups. (NOTE: This section does not make the District President the automatic representative of the district, neither does it bar the election of the District President or any other of the District officers to membership on the State Committee.)

(d) Vacancies occurring on a committee shall be filled by the committee until regular election time.

Sec. 6. AUTHORITY.

(a) The State Secretary shall be authorized to interpret rules with authority to impose the proper penalty.

(b) All questions of eligibility, or of any other matter subject to investigation, must first be submitted to the State Secretary, who shall make a ruling thereon after hearing and/or examining the evidence of both sides and/or other party or parties concerned with authority to impose the proper penalty. If either the defendant or the plaintiff is not satisfied with the decision, appeal may then be made to the State Appeal Board through the State Secretary. In the event that the State Secretary fails to act within one week, an appeal may be made direct to the State Appeal Board either through the State President or the State Secretary. After hearing and/or examining the evidence submitted by both and/or other party or parties concerned the State Appeal Board shall render a decision in the matter. If either party is still dissatisfied with the decision or if the State Appeal Board fails to act within one week, either party may appeal to the State Executive Committee through the State Secretary provided the party or parties appealing shall pay the entire expenses of the State Executive Committee when called together for this purpose. The State Executive Committee shall then hear and/or examine the evidence submitted by both sides and/or other party or parties concerned and render a decision. This last appeal shall be final and anyone seeking redress through any other channel shall forfeit their membership in the Georgia High School Association for a minimum period of one calendar year. No other method of appeal shall be held valid and any appeal, must begin with the first step outlined and not eliminate any step until

reaching the final court of appeal, the State Executive Committee. In any case where the decision by the State Executive Committee is in favor of the appealing party or parties the State Executive Committee may charge the expense of the meeting to the Georgia High School Association and reimburse the appealing party or parties.

Sec. 7. VOTE. Each school shall have one vote in a District meeting and each member of the State Executive Committee shall have one vote in a State Executive meeting. In any case where a member of the State Executive Committee is unable to attend a State Executive Committee meeting, the District President shall have the power to appoint some schoolman from the membership of his district to represent the district at this particular meeting.

Sec. 8. AMEND CONSTITUTION AND BY-LAWS. It shall take a two-third vote of the State Executive Committee to amend the Constitution. A majority of votes shall be required to amend the By-Laws. Changes shall not go into effect until the beginning of the next school year. Any proposed changes in the Constitution must be submitted to the Secretary in writing by March 1. These proposed changes shall be submitted by the State Secretary to each District President not later than April 1st.

Sec. 9. ANNUAL MEETING. The Georgia High School Association shall meet in executive session in June of each year on such date as may be designated by the State Committee. The State Officers in conference shall set the time and the place. In addition to the annual meeting the State President shall call a meeting in either December or in January for the purpose of studying proposed legislation so that such proposals can be passed on to the various districts for their opinions prior to the annual meeting.

Sec. 10. SUSPENSION OF A SCHOOL. The District Executive Committee and/or State Executive Secretary has authority to suspend any school under its jurisdiction from membership in the Association on sufficient evidence of violation of the rules of the Association, with the provision that the suspended school may appeal in the manner presented in Art. IV. Sec. 6. The penalty may be fixed as suspension for the remainder of the playing season and forfeiture of games or events won, and/or the suspension from membership for twelve months.

ARTICLE V—General Provisions

Sec. 1. REPORTS.

(a) The Principal or Superintendent of each member school shall make reports to the District and State Secretaries at the time prescribed by the By-Laws and in the manner called for, and also

such other reports as may be called for by the District or State Committee.

(b) The Secretary of each District, or his representative, shall make a written report of the financial condition of his district organization and on all activities in his district naming champions in basketball and track, if any be declared by the District Committee, and all other district activities, to the State Executive Committee at the annual meeting.

(c) All reports of a District Secretary to the State Executive Committee concerning entries in the State Basketball tournaments, and the State Meet or concerning any routine matter pertaining to the Georgia High School Association, shall be addressed to the State Secretary. These reports shall be filed in the office of the State Secretary for future reference.

Sec. 2. CONTESTS. Each district or region may hold annual contests in reading, declamation, music, debate, spelling, essay, home economics, athletics, typing, shorthand, agriculture, and other forms of contests which may be authorized by the State Executive Committee calculated to promote the cause of education on dates to be announced in this Bulletin under the rules governing the State and District or Regional Meets. Schools will compete in their own classification in State, District, and Regional meets. Winners in these District and Regional meets may be sent to the State Meet in both athletic and literary events.

Sec. 3. TREASURER. The Treasurer of each district is required to make an itemized statement of the income and outgo of all funds to the District Executive Committee. The State Treasurer is required to make a similiar statement to the State Executive Committee. When a new Treasurer is elected, any balance must be turned over to the new officer immediately.

Sec. 4. OFFICE. The permanent office of the Georgia High School shall be the office of the State Executive Secretary-Treasurer. From this office shall be sent out bulletins, and all other routine blanks and forms. Requests for such material shall be addressed to the State Secretary. The person in charge of the State Office shall have charge of making all arrangements for holding and conducting the State Meets and Tournaments.

By-Laws

Sec. 1. A student is eligible to represent his or her school of all classifications unless otherwise noted, in interscholastic contests:

- Item (1) Who is a regular student taking four units of work.
 - Item (2) Who meets the requirements of the normal semester or years of enrollment. (See Section 6, Item II of Definitions.)
 - Item (3) Who is not a special student.
 - Item (4) Who has passed in three unit subjects or their equivalent the previous semester.
 - Item (5) Who was properly registered within 15 calendar days of the beginning of the semester.
 - Item (6) Who is an amateur.
 - Item (7) Who is not playing on a school team and some other team during the same period of time. Period of time means from the time a pupil reports out for his school team until the end of the season in that sport. (This means that a pupil is free to play with an independent team so long as he has not reported out for his school team, but when a pupil reports out for his school team, he cannot play from then on to the end of the sports season with any one except his school team.)
 - Item (8) Whose department satisfies the requirements of the school authorities.
 - Item (9) Who is not a four-year or a senior high school graduate. (Note: A pupil who has met the graduation requirements of his high school and who is qualified for graduation is considered a graduate.)
 - Item (10) Who has not played four years of high school competition in that sport or event.
 - Item (11) Who has not attained his or her 19th birthday prior to September 1st.
 - Item (12) Who is not a migrant student of less than a year's standing.
 - Item (13) Who has not participated in any unauthorized game or contest.
- Sec. 2. A School to be eligible to participate in inter-scholastic contests in this Association.
- Item (1) Shall be a member of the Georgia High School Association.
 - Item (2) Shall be an accredited senior high school.
 - Item (3) Must pay annual dues to the State Secretary-Treasurer.

It is the responsibility of the individual school to see that dues reach the State Secretary-Treasurer. Dues paid on or before October 15 will be 20c per pupil A. D. A. as based on the report made to the State Department of Education for the previous year, with the minimum dues for any school being \$15.00. Dues paid after October 15 will be 22c per pupil A. D. A. as based on the report made to the State Department of Education for the previous year, with minimum dues for any school being \$16.50.

After Oct. 1st, no school is eligible to participate in any contest until its membership dues for the current year are paid.

- Item (4) Shall be governed by person or persons who believe in fairness and honesty, an evidence of which shall be the strict observance of all rules and regulations in regards to eligibility of contestants representing their school.
- Item (5) Must not have been disqualified as a member school for violation of the Constitution or By-Laws within one year.
- Item (6) Shall employ no athletic coach, nor anyone on its athletic coaching staff who is not a full-time teacher, certified by the State Department of Education, and receives his or her entire pay from the Board of Education that employs him or her. (A coach not employed by the Board of Education but who lives in the community and earns his living in some other manner but gives his time to the school is strictly in violation of this rule.)
- Item (7) Must abide by all rules of the State organization and also the District organization when the rules of the District organization are not in conflict with the rules of the State organization.
- Item (8) Shall not play independent team or teams of other schools not a member of this or some allied organization, except college freshmen and then not in football.

Exceptions:

1. Member schools may schedule and play junior high schools.
2. Member schools may schedule and play amateur baseball teams provided that there is no objection on the part of the school authorities where the independent team is located and that in no case will an independent team use any boy enrolled in a high school if there is objection by local school authorities.

3. Member schools may participate in interscholastic contests with member schools of a private non-state association provided that all transfer pupils of the member school of the private school association be eligible only after a full year's attendance at the private school concerned.
4. A member school may schedule and play a non-accredited high school provided that the non-accredited high school is in the same school system as the member school.

Item (9) Must make out complete eligibility papers which shall consist of **ORIGINAL** and **TWO CARBON COPIES** of the Eligibility Certificate (Form E-2) and an Individual Sheet (Form E-1) for each player on the eligibility certificate for whom no individual sheet has been previously filed, and forward to the **STATE SECRETARY** at least **TEN DAYS** before the first game or contest. The State Secretary will return to the school one of the carbons certified under seal of the Georgia High School Association.

The original report for any athletic sport shall show the first game or contest in that sport, giving the date, place and opponent. Each game played prior to the proper filing of the eligibility report shall be forfeited and in addition thereto, a fine of \$10.00 shall be levied against the school for delayed eligibility list; payments of fine or fines for any delayed eligibility report shall be made to the State Secretary. Failure to pay such fine shall prohibit the school from entering any contest. Deadline for payment of fine shall be ten days from notification date. The State Secretary is authorized and directed to suspend from membership any school which fails to file eligibility reports. The State Secretary is authorized and directed to reject any eligibility list not submitted with **ORIGINAL** and **TWO CARBONS** and to return same to the school concerned.

Item (10) Must make out complete eligibility papers and exchange with competing school before each contest.

- Item (11) a. Shall allow only one football game per week by the same team on the season average.
b. Shall allow only two games of baseball per week by the same team. (Exception—tournaments)

Item (12) Shall allow no basketball team to play more than thirty basketball games during the season. (This does not include District, Regional and State Tournaments.)

-
- Item (13) Shall allow its basketball team to enter only one tournament in addition to the District or Regional Tournament. (The State Tournament is considered to be a continuation of the District or Regional Tournament in which a team participates.)
- Item (14) Shall allow no student to switch from one team to another so as to engage in more than one football game per week or more basketball games per week than set by the regulation.
- Item (15) Shall provide strict physical examination by a competent physician of each and every contestant at the beginning of each season in each sport.
- Item (16) Must fill out the blanks prepared by the State Executive Committee provided for the District Meet one week before that event and forward same to the District Secretary.
- Item (17) Shall not enter any inter-district basketball tournament unless such entry is approved by the District Executive Committee.
- Item (18) Shall in no case permit spring football practice to continue longer than six consecutive calendar weeks.
- Item (19) Shall not allow its football team to engage in any inter-school practice and/or scrimmage in football.
- Item (20) Shall not cancel any game contract that has been properly executed without the agreement and consent of the other school concerned. Any school failing to carry out a game contract shall be suspended for one full calendar year. (This means that if a cancellation should be made on the last game of a football schedule, that the suspension would continue up to and include the corresponding date of the next calendar year.)
- Item (21) Shall not compete in any interstate tournament or meet in which three or more schools participate, nor in any interstate contest between two schools which involves a round trip exceeding 600 miles, unless such event has been sanctioned by all interested state associations through the National Federation of State High School Athletic Association.
- Item (22) Shall not permit any of its teams to participate in any post season game or contest or in any so called "bowl or All Star" game or contest, except where specific authorization has been given by the State Executive Committee.

- Item (23) Shall not permit any of its students to represent the school in any interscholastic activity unless such participants meet the eligibility requirements of the Georgia High School Association.
- Sec. 3. Each District organization, through its Executive Committee or proper official or in general session.
- Item (1) May pay its Secretary-Treasurer a salary of \$50.00 or more a year.
- Item (2) Shall collect and pay 5 per cent of the gross receipts of all basketball tournaments held within the District to the State Treasurer within five days after the close of the tournament, these funds to be used to defray the expense of the State Association. (Exception, any basketball tournament confined strictly to schools in the same county and held after the District tournaments have been completed shall not be liable for 5 per cent of the gross receipts.)
- Item (3) Shall collect through its District Secretary and pay to the State Secretary 10% of the gross receipts of all play-off and post-season football games. Payment shall be made to the District Secretary within five days after such game is played. The school or organization sponsoring such game shall be responsible for payment. It is the responsibility of each school participating in such game to make it clear to the sponsoring agency that payment is a part of the condition under which the game is played, and that in the event that the sponsoring agency does not make payment each school participating in such game will be equally liable for one-half of the payment.
- Item (4) Shall provide suitable medals and trophies for individual winners and cups or banners for winning schools in District competition.
- Item (5) May assess sufficient fee for District Meet entrants to pay expenses of judges, printing, etc., and expenses of delegates to the State Meet.
- Item (6) Shall play girls' basketball under the rules approved by the State Executive Committee.
- Item (7) Shall allow no tournament in which member schools participate to be held in its territory except on permission of the District Committee and on the assurance that the tournament will be conducted ac-

ording to the regulations of this Association. Penalty for violation of this rule is found in Art. IV, Sec. 10 of the Constitution and By-Laws.

- Item (8) Shall make such rules as may be necessary to successfully operate the District organization, provided the rules are not in conflict with the rules of the State organization.
- Item (9) Shall determine the place or places for the District Meet and basketball tournaments, provide for admission fees, division of funds with local school, and other details necessary for the successful operation of the Meet and tournaments.
- Item (10) Shall, through its Secretary, certify as to the winners in the District basketball tournament ten days before the State Tournament, and as to the winners in all events of the District Meet ten days before the State Meet, to the State Secretary. The full name of each contestant shall be given.
- Item (11) (a) Schools having an agricultural department are permitted to have F. F. A. basketball teams and to hold tournaments provided the rules and regulations concerning the eligibility of students and the conducting of tournaments as outlined in the By-Laws of the Georgia High School Association are strictly observed. The District Committee in whose area the school is located and where the tournament is held shall have jurisdiction concerning any matter pertaining to eligibility or the tournament.
- (b) Schools that are not members of the Georgia High School Association, but that have an agricultural department may be permitted to participate in games or tournaments conducted for or by F. F. A. basketball teams, provided the principal or superintendent of the non-member school shall apply to the District Committee for permission to play and agrees to abide by the rules and regulations concerning eligibility of students as outlined in the By-Laws of the Georgia High School Association.
- Item (12) Shall determine if schools within its District may enter any approved inter-district tournaments.
- Item (13) Shall furnish a copy of the complete results of all district contests held in and for the district to each participating school in the district.

- Sec. 4. The State organization through its Executive Committee or proper official:
- Item (1) Shall pay its Secretary-Treasurer according to the contract executed by its authorized representatives.
 - Item (2) Shall provide an adequate place for the State Basketball Tournament and the State Meet.
 - Item (3) Must provide an official receipt for all dues and fees received from any source, and shall provide for annual audit of the State Association finances by a firm of auditors or a certified public accountant.
 - Item (4) Shall pay the State organization officials sixteen cents per mile, one way, as traveling expenses when on official business.
 - Item (5) Shall determine if any Inter-District or State Tournament shall be allowed and determine the place or places where they shall be held. No Inter-District tournament shall be authorized unless such tournament has been approved by the District Executive Committee in whose district the tournament is to be played.
 - Item (6) Shall provide eligibility blanks to each and every member school in sufficient quantities to supply their needs for the year. Those blanks shall have spaces to include the name, exact date of birth, grade, and number of years on teams not including this year, for each individual on a team.
 - Item (7) Shall pay to each District Secretary \$5.00 per member school for the respective district.
- Sec. 5. All Class AA schools shall be governed by the same rules as other schools, with the following exceptions:
- Item (1) a. Riverside, Darlington, and G. M. A. are classified as associate members with dues based on 50% of their A. D. A. These three schools will not be eligible to compete for the football and the basketball championships, but may compete for championship in other activities under the regular eligibility regulations of the GHSA.
 - b. Any member school of the GHSA may schedule and may play the above mentioned schools in any activity with the member school playing under high school eligibility rules and the opposing school using any of its pupils to which the member schools might

agree, provided that such agreement be made in writing not less than ten days prior to the game or contest.

c. Riverside, Darlington, and G. M. A. may schedule and play each other under any conditions as they may see fit.

- Item (2) Class A schools may play college freshmen or junior colleges in any sport desired.
- Item (3) Class A Boarding Schools which are members of the Mid-South Association will be permitted to enter any tournament or meets conducted by that Association in accordance with its rules and regulations when that tournament or meet is confined to member schools of the Mid-South Association.
- Item (4) An exception to Section 2, Item 11 shall be made for Class A schools in basketball. A Class A school may play three basketball games per week by the same team.

Sec. 6 Definitions:

- Item (1) AN AMATEUR is defined as one who has never violated his or her amateur standing by receiving money, tuition, board or pay of any description as compensation for playing on a professional athletic team or in a professional exhibition, or playing under an assumed name. This rule does not prevent a pupil from playing on a semi-pro ball team during the summer vacation or from participating in summer camp work. (Note: To violate any of the above will be interpreted as subsidization.)
- Item (2) A UNIT OF WORK is a course of study for which one Carnegie unit will be allowed if completed. (Subtraction and/or cancellation of units already earned shall not be retroactive.)
- Item (3) INTERSCHOLASTIC COMPETITION IN THIS ASSOCIATION is interpreted to mean engaging in contests with member-schools only, or with college freshmen in all sports except football. Interscholastic competition with non-member schools is forbidden.
- Item (4) MIGRATORY RULE—Any pupil who changes schools after enrolling in 9th grade is a migrant. A migrant pupil must remain in the school to which he or she has transferred one full calendar year before he or she may become eligible.

A pupil who transfers from one school to another because his parents transfer or move their residence is eligible in the high school of his parents' residence provided he meets all other requirements.

Promotion from the 9th grade of a Junior High School to a Senior High School in the same service area shall not be considered a change of schools provided the pupil has completed all of the grades offered in the school from which the pupil has transferred.

- Item (5) REGISTRATION means the enrolling of a student in any manner.
- Item (6) A SPECIAL STUDENT is a person taking work in a school which does not carry credit in terms of Carnegie units; or one who is repeating work already passed, or, a person who is allowed special privileges and is not required to fulfill all duties that pertain to a regular or normal student.
- Item (7) A SCHOOL'S SERVICE AREA is defined as one from which a school normally draws its pupils. Whenever claim is made for eligibility of a pupil on the basis of transfer into a school's service area, it must be apparent that the parents of the pupil **have moved from the area** usually served by the school which he left and into the second school's service area.
- Item (8) A YEAR'S PLAY constitutes the entering of competitive play in a sport by a student in any manner, either as a substitute for just one play or more; or the playing of the entire season as a regular player on the team.
- Item (9) POST-SEASON and PLAYOFF GAMES—Any game played after the conclusion of the regular schedule shall be a post-season game.
- Item (10) The NORMAL SEMESTERS OR YEARS OF ENROLLMENT of a pupil in the last four grades of high school is 8 consecutive semesters or four consecutive years. A pupil will be ineligible for further participation in interscholastic contests 8 consecutive semesters or four consecutive years from the date of first enrollment or entrance into grade 9.
- Item (11) MAKE UP WORK will be accepted on the same basis as make up work is provided for all other pupils in the school concerned but with the limit of such make up work for the 1st semester ending ten calen-

dar days after the close of the 1st semester, and with the limit for make up work for the 2nd semester ending with the beginning of the next semester.

Sec. 7 Special Regulations.

- Item (1) AGREEMENT BETWEEN PROFESSIONAL BASEBALL AND THE HIGH SCHOOL FEDERATION—Adopted by Georgia H. S. A.

No student of a high school which is a member of the National Federation of High School Athletic Association shall be signed to a professional baseball contract until the day following his graduation, or, if he has left school, until the day following the graduation of his class; nor shall any representative of Professional Baseball initiate or participate in any negotiations which would violate such boy's high school athletic eligibility; except that a boy out of school one year or longer, may, with the consent of his parents, apply to the Commissioner for permission to sign a contract and if, in the judgment of the Commissioner, the circumstances justify it, he shall approve the application and so notify all clubs. Such player may be signed to a professional contract fifteen (15) days, subsequent to the date of the Commissioner's notice.

Penalties for Violations—

A. For Professional Baseball—Any contract made in violation of the above agreement shall be declared null and void, and the offending club shall be permanently prohibited from using such player. Also, any club which fails to establish that it did not know and by exercising reasonable care and diligence, could not have known that the player was connected with high school baseball and was still eligible therefor, shall be fined \$500.00 Any club official or employee conducting any such negotiations and who does not establish that he did not know, and by exercising reasonable care and diligence could not have known of such interference with players eligibility, shall be ineligible for one year.

B. For High School Officials—Any school whose employee or official encourages or collaborates in such negotiations will be suspended from the state

high school association and made ineligible to compete with other high schools for a period of one year.

Item (2) POST-SEASON, BOWL, and ALL-STAR GAMES

No member school shall participate in any post-season game and/or contest except with approval of the State Executive Committee in writing at least ten days prior to the playing of such game or contest.

All so-called "All-star" and/or "bowl" games are prohibited except where specific approval of the State Executive Committee is given when such contest is for the benefit of a worthy charity or for educational purposes within the High School Association. It shall be the duty of the State Executive Committee to approve any charitable organization or to designate the educational purpose for any authorized game and/or contest. Participation of any pupil in any unauthorized game and/or contest shall render that pupil ineligible for all further participation.

In any case where an application for sanction of a "post-season" and/or "bowl" football game is approved, only the state championship team in its respective class will be permitted to participate in such a game.

In any case where an application for sanction of a "post-season" or "bowl" football game is approved, if any team participating in such game is not from the State of Georgia, clearance for the participation of the non-Georgia team must be made through the office of the State Secretary and in accordance with the regulations of the National Federation of State High School Athletic Association.

Item (3) SPORTSMANSHIP COMMITTEE—The State Sportsmanship Committee shall consist of the State President, the State Secretary, and three members of the State Executive Committee appointed annually by the State President.

Cases of bad sportsmanship shall be reported to the State Secretary who will call a meeting of the Sportsmanship Committee to hear the schools and/or parties involved. The expenses of the Committee meetings shall be paid by the Georgia High School Association.

After hearing the reports and evidence of schools and/or parties involved the sportsmanship committee shall have the power to take such action as it may see fit up to the suspension of the offending school or schools from membership in the Association for one calendar year.

- Item (4) **CERTIFICATION OF ATHLETIC OFFICIALS**—A definite plan for the certification of Athletic Officials shall be set by the Georgia High School Association. The State Executive Secretary-Treasurer is instructed to develop such a plan as rapidly as possible with full authorization to proceed with the plan.
- Item (5) **VIOLATION OF ELIGIBILITY RULES**—Any school violating an eligibility rule whether it is due to carelessness, wilfulness, ignorance or any other cause shall be fined not more than fifty dollars (\$50.00) for each offense and/or shall be suspended from the Association for a period not less than one whole semester.

A school which after investigation is adjudged guilty of violating the rules of the Association shall pay the costs incident to such investigation; such cost to be in addition to fines or penalties assessed. Failure to pay the cost shall result in suspension or in lengthening the period of suspension.

The Executive Secretary-Treasurer is authorized to make such investigation as may be necessary and to judge whether or not a school has violated an eligibility rule. If a school is adjudged guilty, the Executive Secretary-Treasurer is authorized to direct the penalty or penalties. Any school adjudged guilty may appeal in the manner prescribed in Article IV, Section 6 of the Constitution.

A school adjudged guilty must accept the ruling of the Executive Secretary-Treasurer and pay the fine or take an appeal within ten days of the ruling.

- Item (6) **SCHOOL PASSES**—The State Secretary shall issue to each member school a state pass for the Superintendent, Principal, and Athletic Coaches of the school as listed on the information sheet sent in by the school. The name of person to whom the pass is issued shall be written on the pass. The pass will admit the person named and one other to any high school game or contest in the State of Georgia.

(NOTE: These school passes are for the use of school personnel only and are void if presented by any person other than the one named on the pass.)

- Item (7) **MIGRATORY HARDSHIP COMMITTEE**—The Migratory Hardship Committee shall be appointed by the State President from the membership of the State Executive Committee, one member coming from each class of schools with staggered terms. (For the first year in which this committee will operate, each member is appointed for a one-year term, school year of 1951-52; thereafter the appointees shall be on a staggered basis as set by the State Executive Committee.

The Migratory Hardship Committee shall have the authority to set aside the effect of the Migratory Rule upon an individual student when in its opinion the rule works an undue hardship upon that student, provided such action shall be the result of the following procedure:

1. The Migratory Hardship Committee shall meet three times a year to consider requests to have the rule set aside for the benefit of individual students and shall consider such requests at the three meetings held for that purpose, but not at any other meetings of the committee. The date and place of the three meetings shall be set by the Executive Secretary, which dates shall be as soon after September 20, November 15 and January 25 as practical. The principals of all member schools who have filed requests to have the effect of the rules set aside for the individual students shall be notified by registered mail of the time and the place of the next meeting at which such requests will be considered not less than ten days before the meeting.

2. A request will be considered at the first meeting only if complete information concerning the case is filed with the Executive Secretary on or before September 20th, and at the second meeting only if the information is filed on or before November 15th, and at the third meeting only if the information is filed on or before January 25th, unless the circumstances upon which the request is based developed between September 20, or November 15, or January 25 and the date set for the next meeting.

3. The conditions which caused the student to

fail to meet the eligibility requirements must have been beyond the control of the school, the pupil, and/or his parents, and such that none of them could have reasonably been expected to comply with the rule the violation of which is involved. Ignorance of the rule on the part of any or all of them shall not be considered sufficient cause for setting aside its effects.

4. The decision of the Migratory Hardship Committee to set aside the effects of the rule in each individual case shall be unanimous to apply, and such decision shall not be considered as setting a precedent for other cases of a somewhat similiar nature.

Athletics

TRACK AND FIELD EVENTS

- Sec. 1. The Interscholastic Edition of the Track and Field Rules is sanctioned by the National Federation and the National Collegiate. The rules are made jointly by the committee of representatives of the National Collegiate Athletic Association and of the National Federation of State High School Associations. The rules apply to either high school or college meets, but the interscholastic edition emphasizes provisions which apply specifically to high school meets. The National Federation Edition of Track and Field Rules is the official guide for Georgia High Schools with the exceptions as may be found in special regulations listed below.
- Item (1) Each school may have two entries in each event.
- Item (2) No contestant may enter more than two events and the relay, and in no case may any contestant enter more than one track event 400 yards or greater in which he competes as an individual. (Exception Class AA to be set by the District-at-large.)
- Item (3) There shall be thirteen track and field events as follows:
- 100 Yards Dash, 220 Yards Dash, 120 Yards High Hurdles (39"), 180 Yards Low Hurdles (30"), 440 Yards Dash, 880 Yard Run, One-Mile Run, Half-Mile Relay (4 men), Shot Put (12 Pounds), High Jump, Broad Jump, Pole Vault, Discus (High School Weight, 3 lbs. 9 ozs.)

(Exceptions—Class AA—the Javelin Throw added to above events.)

- Item (4) The relay teams in the State Meet may be made up of the representatives from the district or region, provided that each man in the relay is a representative in some other track or field event. (Exceptions—Class AA—does not apply).
- Item (5) In the State B and C Track Meet each district may have two entries in each event. In the State AA and A Track Meet each region may have three entries in each event.
- Item (6) In case of a tie for first or second place in any district track or field event, the contest must be continued or reheld until the representatives of the district are determined. In case of a tie in the original contest the points shall be divided equally among the tied contestants. The continued or reheld contest shall carry no points. In case of a tie in the State Meet, the tie shall stand, and the points will be divided equally among the tied contestants. (In a district meet if only two contestants are tied for first place, no continued contest or reheld contest will be necessary to determine the representatives for the State Meet; if more than two contestants are tied for first place the contest must be continued or reheld to determine the representatives; if one contestant is first place winner, and two or more contestants are tied for second place, a continued or reheld contest will be necessary for those who tied for second place to determine which one qualifies for the State Meet in addition to the first place winner.)
- Item (7) Schools which finish 1st, 2nd, 3rd, and 4th in total points in the State Meet will be awarded trophies.
- Item (8) In the District or Regional Meets in the Shot Put, Discus Throw, and Broad Jump events the giving of qualifying and the final throws is optional. If the District Executive Committee wishes to do so it may dispense with the qualifying trials and allow each contestant in any of these three events only the three trials, only the best of the three trials to count.
- Item (9) The order of events for both District, Regional and State Meets will be in order as set in the Track and Field Guide for that type of meet.

- Item (10) The time schedule for District and Regional Meets shall be given to each school participating in the meet prior to the start of the meet.
- Item (11) The State Meet will be scheduled as a two day meet according to the schedule announced prior to the State meet, with preliminaries scheduled one day and the finals the next. If weather conditions cause a change in the schedule events may be held at night, or if necessary to condense the meeting to one day because of weather conditions, events may be run morning, afternoon, or night.
- Item (12) In the State Meet preliminaries may be eliminated and finals held in any of the field events provided that notice is given prior to the beginning of the event.
- Item (13) Four places will be counted in District, Regional and State Meets. First place shall count 7 points; second place, 5; third place, 3; fourth place, 1. (Exceptions Class AA.)

TENNIS

- Sec. 2. Tennis is a District, Regional, and State event separate from track and will not count for points in winning the track cup in District or State Meet. The District or Regional winners who will be certified to the State Office by the District Secretary or the Regional representative will be eligible to go to the state meet. District elimination tournaments will be arranged by the Executive Committee of the respective district. Regional elimination tournaments will be set by the respective regions.

Tennis requires two players for the doubles and one player for the singles. A boy or a girl may not participate in both singles and doubles. Four boys will constitute a boys team and four girls will constitute a girls team making a total of four per team from each school. There will be no mixed teams. Four certified players may be eligible to play in any elimination or final matches at discretion of the coach.

GOLF

- Sec. 3. (a) Golf for Class AA will be conducted on the basis of plans as set by Class AA.
- (b) Golf for Class A, Class B, and Class C will be an open State event. Contestants in golf will be certifi-

ed direct to the State Secretary by the local superintendent or principal. Notification of entry in golf must be filed with the State Office not later than April 23, 1952.

CROSS COUNTRY

- Sec. 4. (a) Cross Country will be a State event open to schools of all classifications.
- (b) Contestants in Cross Country will be certified direct to the State Secretary by the local superintendent or principal. Notification of entry in Cross Country must be filed with the State Office not later than Nov. 9, 1951.
- (c) A minimum number of 5 and a maximum number of 7 shall be the entry from any one school.
- (d) The distance for the Cross Country race will be two miles.
- (e) The first five finishers on each team will count for the total team score.
- (f) The Cross Country race will be held at Atlanta, Ga., Waterworks Course, Nov. 16, 1951, 3:30 p. m.

SWIMMING

- Sec. 5. (a) Swimming will be a State event open to schools of all classifications.
- (b) Swimming will be held at the University of Georgia, Athens, Georgia, on March 15, 1952.
- (c) Contestants in Swimming will be certified direct to the State Office by the local Superintendent or Principal. Notification of entry in Swimming must be filed with the State Office not later than March 8, 1952.

Football

- Sec. 6.
- Item (1) Schools shall be classified into four groups for football purposes.
- The classification of schools will be obtained as follows:
- a. The four-year high school will be used as a base, and for a three-year high school one-third of the

ADA will be added to get the classification figure.

- b. The co-educational school will be used as a base, and for a single sex school the ADA will be doubled to get the classification figure.
- c. The classification of a school will be determined by the following scale:

Class AA—650 and up

Class A—300 to 650

Class B—200 to 300

Class C—under 200

- Item (2) Classification shall be for a period of two years. Reclassification will be based on the ADA figures for 1950-51. Schools will be advised of their classification by October 1, 1951. Any requests to move into a higher classification will have to be filed by October 15, 1951.
- Item (3) A school on application to the State Secretary may be permitted to move from a lower to a higher classification but a school will not be permitted to change from the classification as set by its classification figure to a lower classification. Any school which moves from a lower to a higher classification by application must remain in the higher classification until schools are reclassified on a state wide basis.
- Item (4) The State will be divided into four regions in each class. Regional lines will not be the same for all classes. A region composed of a large number of schools may be divided in sub-regions.
- Item (5) The Region committee for each classification shall be composed of one member of each school in said region.
- Item (6) The Region committee shall determine the champion of each region. Each region will determine its own champion in its class, and this champion will have to be determined by the Saturday following Thanksgiving Day, (4th Thursday).
- Item (7) The championship in each region in its classification will be determined by the region committee on the following basis:
 - a. By percentage standing, counting the regional or designated games, and in case of a tie between two teams, a playoff shall be held.

- b. In case of a tie among more than two teams, the percentage standing counting all games with schools of the same classification shall be used to determine the regional winner.

NOTE: In calculating the percentage standing the games won shall be divided by the games played with any tie games counting as $\frac{1}{2}$ game won.

Item (8) To qualify for the championship of a region or sub-region a team must play a minimum number of games with teams in its region and classification as follows:

- a. If the region or sub-region is composed of 8 or more schools, the minimum number of games will be six.
- b. If a region is composed of less than 8 schools, the minimum number of games will be two less than the number of schools in said region.
- c. In a case where a school is assigned to a region after the region has been determined (i. e., a school beginning football) any games played with that school will count but in case the region is less than eight teams it will not increase the minimum number of games for that region until the year following the assignment of the new school.

NOTE: EFFECTIVE THE FOOTBALL SEASON OF 1952:

The following will replace Item (8):

- a. Any region with ten or more teams (schools) will be sub-divided. Every school in a region or sub-region must play each team in that region or sub-region to be eligible for the football championship. No region will consist of more than 18 teams.
- b. Any contract between teams outside of a region or sub-region of the same classification, extending beyond the football season of 1951 may be voided, if necessary, to complete the regional or sub-regional schedule.
- c. Regional or sub-regional meetings for scheduling purposes must be held by Feb. 1, 1952; no school in a region or a sub-region may schedule any football game prior to the regional or sub-regional meeting.

- d. In any case where a school does not play a regional or sub-regional schedule or qualify for championship, any games played by that school will not count for or against any opponent.
- Item (9) For the season 1951, all teams which are not able to schedule the required number of games to qualify for their regional championship, will be allowed to substitute game or games with school or schools of the same classification or higher, provided that notification of the game or games which are to be substituted be sent to the State Secretary prior to September 1, 1951.
- Item (10) In any case where two teams have played each other more than once during the season, only the first game shall count in the regional standing. (Exception—a tie among more than two teams.)
- Item (11) The State Football Committee shall be composed of one member from each region of each classification and the State Officers of the Georgia High School Association. The member from each region of each classification shall be elected by the schools of the respective region.

The terms of the members of the State Football Committee shall be for two years. The members from the even numbered regions shall be elected in the Spring of the even numbered years and the members from the odd numbered regions shall be elected in the Spring of the odd numbered years.

In case a vacancy occurs in any region for any reason, the region is authorized to fill the unexpired term at the next meeting of the region after the vacancy occurs.

The officers of the State Football Committee will be a Chairman and a Secretary who will be elected from the membership of the State Football Committee. The officers so elected shall serve until their terms of office on the committee expire. In case a vacancy occurs in either or both offices, the vacancy shall be filled at the first meeting of the State Football Committee following such vacancy.

The State Officers of the Georgia High School Association shall be ex-officio members of the State Football Committee but with no vote. The Executive Sec-

retary of the Georgia High School Association will assist the Secretary of the committee in taking minutes of meetings, and will mail a copy of such minutes to each member of the committee after the minutes have been checked by the Secretary and the Executive Secretary.

The Executive Secretary of the Georgia High School Association shall be responsible for notifying each member of the State Football Committee of the time and the place of any meeting of the State Football Committee.

- Item (12) The State Football Committee shall set the Regional Divisions for each classification.
- Item (13) For the season 1951 the regional and sectional play-offs shall be as follows:
AA, A, B and C—Region 1 vs Region 2
Region 3 vs Region 4
Winners to meet in final.
- Item (14) All football games played by member schools of the Georgia High School Association must be played under the National Federation Interscholastic Football rules.
- Item (15) There shall be no inter-school practice and/or scrimmage in football.
- Item (16) Spring football practice shall not exceed a maximum of six weeks.
- Item (17) No spring interscholastic football games will be played.
- Item (18) Football practice shall not be started until four weeks (28 calendar days) prior to the date of the first scheduled game.
- Item (19) The maximum number of games that a school may schedule in its regular schedule must be limited to ten games. This limitation of ten games in the regular schedule shall not include play-off games.
- Item (20) The regular schedule of any school must end by Saturday following Thanksgiving Day.
- Item (21) a. In case of a tie in the state final championship game the two tying teams will be declared co-champions.

- b. In case of a tie in any playoff game—sub-regional, regional or sectional—preceding the final state championship game the following point system will be used to determine the winner.

1 point will be allowed for the team that has made the most penetrations of the opponents 20-yard line during the game.

1 point will be allowed for the team that has the greater number of first downs during the game.

1 point will be allowed for the team with the greater net yardage during the game.

If the teams are still tied after the application of this system, the winner will be the team with the greater net yardage.

- Item (22) All football games will be played with a minimum of four officially dressed football officials who are registered under the GHSA plan for the registration of officials, or with the State Association of another state. Violation of this rule shall be treated as a violation of eligibility rules as provided in Section 7. Item (5).

- Item (23) All high schools are urged to publicize the program by contacting newspapers, radio stations, civic clubs, and school assemblies, and any other means possible.

- Item (24) No high school shall belong to any other football organization than that to which assigned by the GHSA and be eligible for membership in the GHSA.

- Item (25) Playoff Regulations:

Date—Playoffs between regions shall be held the first week-end following Saturday after Thanksgiving Day.

State Finals shall be held the 2nd week-end following Saturday after Thanksgiving Day.

Location—Regional and State.

1. By agreement of the schools concerned to play on:
 - a. Home field of one of the schools
 - b. Neutral field
2. No agreement, then by the toss of a coin with the winner of the toss designating the location.

3. The schools of any classification, if they so see fit, may be a two thirds vote of those schools present at a meeting prior to the football season, designate or set the location of the state final championship game for that classification.

Finances:—

1. If played on the home field of one of the schools:
 - a. Visiting team shall receive as a minimum \$1.00 per mile one way to be charged against the expenses of the game.
 - b. Net gate receipts after expenses of the game have been deducted shall be divided equally between the two teams. (Net gate receipts equals all receipts minus all expenses. Concessions and programs will not be included in receipts.)
 - c. Broadcasting and/or televising of the game may be permitted at no charge if the program is a sustaining program. If the program is a commercial, 30% of the charges made for the program shall be paid for the privilege of broadcasting and/or televising which shall be added to the receipts of the game.
 - d. In lieu of the financial arrangements in a and b, the visiting team may elect to receive a flat guarantee.
2. If played on a neutral field:
 - a. Same financial terms shall apply as above, with the competing teams dividing the gate receipts as in b and/or either team having the privilege of exercising the option as in d.
3. Item 3, Sec. 3 of the By-Laws shall apply to all football playoffs, except that the 10% of the gross gate receipts shall be remitted direct to the State Secretary.

Officials:—

1. Shall come from the list of officials registered with the GHSA or with the State Association of another State.

2. Shall not come from any official association nor from officials in town of either competing team unless mutually agreeable.
3. If mutual agreement can be reached as to officials, selection will be on agreement of the schools concerned; if agreement cannot be reached, the State Secretary will select the officials.
4. Officials fees for Regional and State Play-off games:
 - a. Mileage on basis of 10c per mile one way. (To be paid for one car if officials are from same location; to be paid for two cars if officials from different location and not feasible to travel in same car.)
 - b. Receipts under \$2000_____ \$15.00
per official
Receipts \$2000.00 to \$4000.00_____ \$25.00
per official
Receipts \$4000.00 to \$6000.00_____ \$50.00
per official
Receipts over \$6000.00_____ \$75.00
per official
 - c. Receipts in calculating officials fees shall be gross receipts minus federal tax.

Trophies:—

Loser in each regional playoff_____
Regional winner trophy and 25 silver foot-
balls.

Loser in state playoff_____
Sectional winner trophy and 25 silver foot-
balls.

Winner in state playoff_____
State Championship trophy and 25 gold
footballs.

All Region selections_____
11 special awards.

In case of a tie in State final game du-
plicate awards will be made to the teams.

Selections of All Regional Teams:—

1. Each coach will submit to the regional

representative of his classification on the State Football Committee a list of his own players whom he considers worthy of all region.

2. List shall give the name, number, and position of the player. (Form for this will be furnished by the State Office.)
3. A complete ballot will be made by listing these players.
4. Each coach (1 to each school) will have the privilege of casting a ballot.
5. Ballots will be voted and returned to the regional representative for tabulation. In tabulation, first place vote will count 5, second place, 3; and third place 1.
6. After the ballots have been tabulated the regional representatives shall mail a copy of the tabulation with the ballots to the State Secretary.
7. In balloting for selections coaches are not limited to the players whose names appear on the ballot.
8. Release to the press and to the radio of these selections will be made to all at the same time on date set by the State Secretary. Regional representatives will not release any tabulations of selections. (Note: In selections for Class AA, where regional representative is named above, substitute State Secretary.)

BASKETBALL

Sec. 7.

- Item (1) No school may play more than thirty games of basketball with other schools during the basketball season. (This does not include District or Region and State Tournaments.)
- Item (2) A school may permit its basketball teams to enter only such tournaments as have been authorized according to the rules and regulations of the Georgia High School Association.
- Item (3) All boys basketball games shall be played by the

National Federation Basketball Rules. All girls basketball games will be played according to the rules adopted by the State Executive Committee.

- Item (4) Where two basketball teams have the same color of jerseys it shall be the duty of the home team to change colors in the interest of good sportsmanship. In tournaments where two teams have the same colors, both schools shall change.
- Item (5) The officials in all games shall have complete control over all features of the game. In District, Regional and State Tournaments the Committee in charge shall secure the services of a competent scorer. No team shall have the privilege of placing their scorer to check the official scorer at or near the position occupied by the official scorer. Often official scorers are materially hindered by others who call out the number of the offending players and otherwise distract the attention of the scorer.
- Item (6) A school may enter its basketball team in only one tournament in addition to the district tournament. (The State Tournament is considered to be a continuation of the District Tournament in which a team participates.)
- Item (7) All District, Regional, and State Basketball tournament games shall be played with a minimum of two officially dressed basketball officials registered under the GHSA plan for registration of officials or with the State Association of another state.

State and District Meets

LITERARY EVENTS

Sec. 1. The State Executive Committee and each district and region Committee, working under the rules and regulations set out in the Constitution and By-Laws of the Association shall have entire charge of the operation of their respective meets, the selection of judges and officials for each event. They shall:

- Item (1) Provide a time keeper in each event in which there is a time limit to be observed. It shall be the duty of the time keeper to keep an accurate account of the time contestant is consuming. Each time keeper shall be provided with a stopwatch, and time shall be called for each contestant when the time limit is reached. A contestant shall not be disquali-

ffed if the contestant stops promptly when time is called.

- Item (2) Provide one or three judges for each event, and give the judge or judges a written copy of the rules concerning the judging of that event as set out in section and item dealing with the particular event.
- Item (3) Provide programs for each contestant so that they may know where and when to appear for a contest.
- Item (4) Use in District and region literary contests the same type of score sheets that are used in the literary contest in the State Meet. The State Office will furnish each district with a supply of these score sheets.

Sec. 2. In all State Literary Contests in which there are more than two contestants, a rating system of judging will be used so that conference of judges to determine winners may be eliminated.

Sec. 3. Each contest shall be judged on merit according to points set out as essential for judging that contest. The age or size of the contestant shall have no influence in reaching a decision.

Sec. 4. The presiding official in any contest will not by word of mouth, gesture, or any other change of expression, or in any manner indicate approval or disapproval of the manner in which a contestant presents material.

Sec. 5. All mistakes due to error of arithmetic or made contrary to the rules of the contest, and discovered before or after the decision of the judges, shall be corrected. In the use of score sheets for judges there shall be no column in which the judges may tabulate the result.

Item (1) DECLAMATION

Declamation is a contest for boys. It is a contest of delivery. It should be an oration worthy of a high school boy. The subject matter of the dedication should be serious in tone and delivered for the purpose of informing, convincing, and persuading the audience. All purely funny pieces, dramatic readings, and impersonations are barred from consideration. No accessories such as costumes or music will be allowed. The judges will take into consideration the following: (1) sincerity, (2) earnestness, (3) force, (4) voice, (5) polish, (6) grace, and (7) effectiveness of delivery.

The declamation shall not be over six minutes in length. The judges shall select a first, second, third and fourth place winner.

Item (2) READING

Selections for the contest shall be taken from the works of Vachel Lindsay.

Reading is a contest for girls. Each contestant shall be given her selection at the State, District or Regional meet and shall be given 30 minutes to study the selection and then be required to read the selection before an audience. The judges shall select a first, second, third and fourth place winner.

Item (3) PIANO

Each contestant will be allowed ten minutes in which to play two selections. One selection must be taken from Group I, and one selection must be taken from Group II.

Group I

Bach, J. S.—A two-part invention or a three-part invention, or a movement from one of the French or English Suites.

Purcell—A movement from sonata or suite

Scarlatti—A sonata

Haydn, Mozart, or Beethoven—A movement from a sonata

Group II

Brahms—An intermezzo or short piece from Op. 116, 117, 118, or 119.

Carpenter, J. A.—Tango American

Chassins—Prelude in E-flat minor

Chopin—Impromptu in A-flat; or Nocturne in F major Op. 15, No. 1; or Nocturne in G-minor Op. 37, No. 1; or Waltz in E-flat Op. 18; or Polonaise in C-sharp minor Op. 26, No. 1.

Debussy—Arabesque in E major or Arabesque in G

Guion—Sheep and Goats

Korngold—The Brownies Op. 3, No. 4

Liszt—Valse Oubliee or The Nightingale (Alabieff) or Fourth Hungarian Rhapsodie.

MacDowell—Shadow Dance, Op. 39

Paderewski—Chant du Voyageur Op. 8, No. 3

Palmgren, S.—The Swan

Ravel—Pavanne for a Princess

Schubert—Impromptu in E-flat Op. 90, No. 2

Schumann—In the Evening Op. 12, No. 1, or Soaring Op. 12, No. 2

Scott, Cyril: Danse Negre Op. 58, No. 5 or Lotus Land Op. 47, No. 1

The judges will take into consideration the following:

1. Accuracy (Notes and Time Value)
2. Technique (Fingering, Faculty, Appropriateness)
3. Rhythm (Steadiness, Tempo, Freedom)
4. Interpretation (Understanding of composition. Expression marks, Contract, General effect)
5. Presentation (Stage deportment, Poise, Stage personality)

Item (4) ONE ACT PLAY

Each district shall hold elimination contests on or before the District Meet, the winning play of which shall be entered in the State Meet. No more than eight persons may be used in the cast, although parts may be doubled. Plays with immoral subjects will receive no consideration by the judges. The District or Regional Secretary must file an official entry for the play winning first place with the State Secretary at the same time he makes his report to the State Secretary for winners of the District or Region Meet. Failure to do this will disqualify the district from competition in this event. No play shall be **more than 30 minutes in length.**

The judges shall select a first, second, third and fourth class winner.

The scoring of points shall be twelve points first place, nine points second place, six points third place, and three points fourth place.

For the current year's contests only tragedies will be used. Whether or not a play is a tragedy will be determined by the publisher's listing.

Plays winning first place in each group at the State Meet are eliminated in both groups for a period of two years. The following plays are barred for the current year in District, Region and State Meets:

"WALL FLOWERS" "FIGUREHEADS"
 "WE BRENTS PAY OUR DEBTS" "FROM FIVE TO FIVE-THIRTY"
 "NOBODY SLEEPS"

Item (5) ESSAY CONTEST, BOYS AND GIRLS

(a) Subject and Contestants: The State President shall select five subjects from current topics discussed in newspapers and magazines as the basis for the Essay Contest.

The subjects must be sent in a sealed envelope to the District

or Regional Secretary, said seal to be broken in the presence of the contestants after having assembled in the room for the contest. The contestants must receive no coaching during the contest.

The contestants, one boy and one girl from each school may write upon any of the five subjects selected, an essay not exceeding 600 words. The essay shall be written in ink. Two hours will be given for writing the essay.

(b) How judged. Verbal and grammatical corrections, spelling, and punctuation shall be considered of less importance than the interest and general effectiveness of the whole composition, but should have weight. The essay shall be judged by the thought, the order, arrangement, and by the elements of style. It is a ready writer's contest and evidence of pre-memorized compositions shall weigh heavily against the contestants. Boys' and Girls' essays will be graded separately and separate awards will be given. The judges shall select a first, second, third and fourth place winner.

(c) Essays Sent: The first place essay in each district shall be sent by District or Region Secretary just as handed to the Committee of the District or Region contest, with the name on a separate sheet, to the State Secretary at the same time he makes his report to the State Secretary of the winners of the District or Region Meet. The District and Regional winners in the Essay do not come to the State Meet for further contests. The State winners are determined from the winning papers sent in from each district.

Item (6) SPELLING

(a) The State Secretary, on or about the first day of April each year shall send, securely sealed, to the District or Region Secretary as many lists of words as the District or Region may have schools entering the contests. The list will consist of 100 words to be spelled by the senior class of said schools on the first Wednesday in April. A minimum of 80 per cent of the words will be selected from the spellers on the State Textbook list; the remaining words will be selected from current news publications.

(b) How conducted. The District Executive or Regional Committee shall appoint for each contesting school a visiting examiner to conduct the contest in each school, said examiner being a superintendent or his representative of some member school. The District or Region Secretary shall send by mail to the Superintendent of the school participating in the contest, the sealed list of words. The outside envelope shall be addressed to the Superintendent of the school participating, the inside envelope shall contain the sealed list of words and the district secretary shall write the name of the visiting examiner on the outside of this envelope. The envelope with the sealed list of words is not to be opened by any

person other than the visiting examiner or his representative. This material may be registered if the district so sees fit, however it is not mandatory. The visiting examiner is directed to select two assistants from the faculty in the school where the examination is being held to assist him in the conduct of the examination. The local spelling teacher may give out the words to the class. Definitions of words may be given.

The examiner shall make a written report of the result of the examination on the report enclosed with the list of spelling words signed by all members of the committee. It shall be sealed and mailed to District or Region Secretary on the same day on which the examination is held with all of the examination papers of the class, together with such written explanation of absence as may be submitted to him. No excuse for absence other than a doctor's certificate will be accepted, except in the case of extraordinary providential hindrance, such as death in the family or some similar circumstance. One hundred words must be counted off for each unexcused absence.

The District or Region Secretary must notify the State Secretary by Monday of the last week in March what schools in the district or region will enter the spelling contests. Every examination not held according to these rules and regulations will be thrown out.

(c) Winning papers. The District or Region Committee may review the list sent in. The District or Region Secretary shall send to the State Secretary the averages of all schools in his district and the papers of the winning schools. The District, Region or State Secretary shall from these data award first, second, third, and fourth places according to whether it is a District, Region or State Contest.

(d) All spelling papers must be written in ink. One hundred errors must be counted off for each paper not written in ink.

In correcting papers count as errors the following:

1. All words so poorly written you cannot read them.
2. All words written as "I" over an "e".
3. All words which show erasures and/or changes.
4. All words erased and/or crossed out and rewritten.
5. All words which are not numbered to agree with the number of the word as given out by the examiner.
6. All words omitted.

Item (7) DEBATE

Each school wishing to enter debate must notify the District

Secretary or Regional Chairman not later than February 25th of its intention to enter the debates for the current year.

Elimination on District and Regional levels will be conducted by one of the following plans as the District or Region may direct:

- (a) The District or Regional Chairman shall group the schools entering in two circles according to geographical arrangements by March 10th and notify each school concerned concerning the groups. Each school so grouped shall present two teams of debaters, one team on the affirmative and one team on the negative, the affirmative team debating at home and the negative team away from home.
- (b) The District Secretary or Regional Chairman shall group the schools entering into two circles by March 10th and notify each school concerning the groupings. Each school so grouped shall present two teams of debaters, one team on the affirmative and one team on the negative. All schools in the same circle shall meet at the same place at a time set by the District or Region.

Where schools drop out, consolidations are to be made by the District Secretary or Regional Chairman, and schools must be ready to meet any assigned contestants on the final date. Should all schools but one in a circle fail to debate, that school shall be declared the winner of the circle and be entitled to represent the school at the District or Regional Meet. If only two schools remain in a circle, these debate on a dual plan. The winners of the respective circles meet in the District or Regional Meet on a dual debate plan, with the affirmative team of each school meeting the negative team of the other school.

Any school entering debate and dropping out without giving at least three days notice to the District Secretary or Regional Chairman shall not be allowed to enter any other literary event that year.

(a) Order of speeches: At all contests, time and order of speeches shall be as follows:

MAIN SPEECHES

First affirmative speaker.....	10 minutes
First negative speaker.....	10 minutes
Second affirmative speaker.....	10 minutes
Second negative speaker.....	10 minutes

PREPARATION OF REBUTTAL

Time for preparation of rebuttal shall be given. The maximum time shall be limited to ten minutes. By unanimous consent of all

participants in the debate, less time for the preparation of rebuttal may be used and the debate continued.

REBUTTAL SPEECHES

First negative speaker.....	4 minutes
First affirmative speaker.....	4 minutes
Second negative speaker.....	4 minutes
Second affirmative speaker.....	4 minutes

Speakers on respective sides must speak in the same order in rebuttals as in main speech.

(b) For 1951-52 the debate subject will be:

Resolved: That All American Citizens Should Be Subject To Conscription For Essential Service In Time Of War.

(c) District and Regional Debates—All of the preliminary debates in the several districts and regions shall be held the fourth Friday in March, at such hours as may be agreed upon or at such time as may be set by the District or Region, and in case of a tie in a circle, the tie must be settled by the following Friday. Both of the winning schools in each circle will be entitled to contest at its respective District or Regional Meet, and the school scoring the most points will be declared the winner. Should there be a tie in points scored by each school at the District or Regional Meet the contest must be continued or reheld until a representative for the State Meet is determined. In case of a tie in the first contest the points shall be equally divided between the tied schools. The continued or reheld contest shall carry no points, but is held merely to determine the representative of the District or Region at the State Meet.

(d) Judging and Scoring: In every debate there shall be three judges. A copy of the instructions shall be given to each judge. In selecting the winners, the vote of each judge shall count 1, a perfect score making 6 points. A school is not eliminated as long as it wins both decisions in its circle.

(e) Instructions to Judges: The judges shall vote from their places without conference. Judges are to consider both the constructive and rebuttal speeches, and should regard proof, organization, refutation and delivery of the constructive speech; and the analysis, refutation and delivery of the rebuttal speech.

The judges will be asked to select the best team of debaters by rating the best team as Number 1, and the losing team as Number 2. In addition the judges will be asked to give each speaker a percentile score.

As a basis for marking the judges will use the following:

Organization and proof.....	50
Analysis and refutation.....	30
Delivery	20

A blank ballot will be furnished each judge similar to the following:

Judge's signature

At the close of the debate each judge shall indicate his choice by ballot and deliver it to the presiding officer. In district and regional debates the presiding officer shall inspect the ballots in the presence of a representative of each school and announce the result. In the State Meet the ballots in each individual debate shall be placed in a properly marked envelope by the presiding officer, shall be sealed and delivered to the Chairman in charge of the State Meet Debates. After all of the debate envelopes have been turned in to the Chairman, he shall forward them to State Meet office, where the State Secretary or his representative shall, in the presence of one representative from each of the contesting schools, open the envelopes, read aloud the ballots, make an official tabulation of the results, and announce the results.

(f) No Visiting: It shall be considered dishonorable for pupils, teachers or followers of one school to visit debates of another school for the purpose of securing information when the two schools are likely to meet on the same question.

(g) Coaching: Coaching is necessary, but does not mean writing speeches. Coaching should be limited to (a) instruction in the art of debating in general; (b) help in the collection of material bearing on the subject; (c) advice, suggestions, directions, criticism, outlines and English as in regular class work; (d) drill on delivery. The coaching must be done by a teacher of the school and not by outside parties. Each school will observe these general principles of honesty for the sake of the pupils.

(h) In all contests the debaters shall be separated from the audience and shall receive no coaching while the debate is in progress.

(i) No Speaker may be interrupted during main speech or rebuttal, nor may any speaker utilize any time other than that allotted for main speech and rebuttal. For violation of this provision, the presiding officer shall forfeit the debate to opponents.

(j) Teams: The teams constituting the debating team from a given school may not change from one team to another or change from negative to affirmative, or vice versa, in order to give the school a stronger representation on that side of the debate. Each school must be represented by the same debaters or an alternate at the District, Regional or State Meet that represented the school for the first circle debate and on the same side of the question that they originally represented.

(k) At the State Meet the State Secretary shall arrange the district or regional winners into two circles with approximately the same number of schools in the respective class in each circle, these to be designated as Circle 1 and Circle 2. (Exception—if there are four or less schools in the State Meet debate in any class these may be arranged into one circle which will be the final debate.) The winning school in Circle 1 shall meet the winning school in Circle 2 for the State Championship. In case of a tie between schools in the same circle before the circle winner is determined, the schools tied shall debate off the tie, each school furnishing two teams. Both teams of the winning school in each circle will be entitled to contest in the final debate, and the school scoring the most points shall be declared the winner. Should there be a tie in points scored in the final debate, a co-championship will be declared.

Item (8) MALE QUARTET

In District, Regional and State Meets the Quartet contest will be Male Quartet. Each quartet will be limited to eight minutes. Not more than two selections may be presented by each quartet. Quartet may be with or without accompanist. The judges will select a first, second, third and fourth place winner.

A Male Quartet shall consist of four male voices carrying the following four distinct harmony parts: (1) first tenor; (2) second tenor; (3) first bass; (4) second bass. Unless these four harmony parts are heard the group will not be considered by the judges.

Item (9) TYPING, BOYS AND GIRLS

Separate contests in typing will be held for boys and for girls. Typing will be contest limited to pupils who are enrolled in their first year of typing. Any pupil who has had any instruc-

tion in typing prior to the beginning of the school year shall not be eligible. Either a boy or a girl may represent a school. This will be a straight copy contest in speed and accuracy and will be graded on the basis of International Typing rules as published by the Gregg Publishing Company. Each contestant will be required to type for a period of fifteen minutes. Each contestant will be given the same copy to transcribe.

Each contestant is responsible for furnishing the typewriter which is to be used in the contest.

The judges will select a first, second, third and fourth place winner.

Item (10) VOCAL SOLO

In District, Region and State Meets there will be a contest in vocal solo for boys and a contest in vocal solo for girls. Each contestant will be limited to seven minutes. Not more than two selections may be presented by each contestant. Vocal solo may be given with or without accompanist. The judges shall select a first, second, third, and fourth place winner.

Item (11) HOME ECONOMICS

The contest in Home Economics will be in the area of Home Nursing.

Each contestant will:

1. Take a written objective-type test relating to the problems in home nursing.
2. Give a demonstration of a home nursing skill.

(Each contestant should be prepared to demonstrate the nursing procedures which are explained in "Red Cross Home Nursing," since any one of these may be assigned the day of the contest.)

References: State Adopted Textbooks:

"Simplified Home Nursing"

"Red Cross Home Nursing"

"Illustrated Handbook of Simple Nursing"

Judges will select a first, second, third, and fourth place winner.

Item (12) SHORTHAND

The contest in Shorthand in District, Regional, and State Meets will consist of dictation and transcription. Rate of dictation will range from 80 to 120 words per minute with total dictation from ten to fifteen minutes. Contestants will be allowed 60 minutes for transcription. Contestants are expected to furnish own notebook and typewriter.

The contest is open to both boys and girls of any grade level in high school.

Contest will be judged on the finished product which will include accuracy in the transcribed material and observance of International Typing rules in the transcription.

Judges will select a first, second, third, and fourth place winner.

Item (13) GIRLS TRIO

In District, Region and State Meets there will be a contest in Girls Trio. A girls' trio shall consist of three female voices carrying three harmony parts namely: first soprano, second soprano, and alto. (Referred to, in music as S. S. A.) Three harmony parts must be heard in order for the group to be considered by the judges.

Each trio will be limited to eight minutes. Not more than two selections may be presented by each trio. Trio may be with or without accompanist. The judges will select a first, second, third and fourth place winner.

Sec. 7. POINTS TOWARD WINNING THE LITERARY CUP

(a) The winners in declamation, reading, boys' essay, girls' essay, piano, home economics, quartet, boys' typing, girls' typing, boys' vocal solo, girls' vocal solo, shorthand, and girls' trio, shall receive seven points for first place, five points for second place, three points for third place, and one point for fourth place towards winning the literary cup in District, Region and State Meets.

(b) The winner of the dual debate at the District, Region or State Meets shall receive twelve points and the loser shall receive nine points toward winning the literary cup. Each school not going to the finals in the District or Region shall receive points up to five according to the number of points received in the preliminary contest in debate. Each school not going to the finals in the State Meet shall receive points up to five, according to the number of points received in the circle debate.

(c) One Act Play and Spelling at the District, Region or State Meets shall receive twelve points for first place, nine points for second place, six points for third place, and three points for fourth place.

Sec. 8. NUMBER OF REPRESENTATIVES

(a) A pupil may represent his or her school in not more than two events in which he or she performs alone. Pupils are not limited as to the number of group events that they may enter.

(b) Each school may have only one contestant in each of the

following: declamation, reading, piano, home economics, girls' essay, boys' essay, girls' typing, boys' typing, girls' vocal solo, boys' vocal solo, and shorthand.

(c) The first place winner in each literary event in each District and Region qualifies to participate in the State Meet.

Sec. 9 TIES

In the case of a tie for 1st place in any district literary event the contest must be continued or reheld until a representative for the State Meet is determined. In case of a tie in the first contest the points shall be equally divided between the tied contestants. The continued or reheld contest shall carry no points, but is held merely to determine the representative of the District or Region at the State Meet.

Sec. 10

Score sheets used in the State Meet in the various contests will be turned in to the chairman of the contest. The chairman will place these score sheets in a properly marked envelope, seal and turn in to office.

The envelope containing the score sheets will be opened in the office in the presence of one faculty representative from each school in the contest, the result tabulated, and the winners announced.

- e. An all tournament team of ten players will be selected at the state tournament and awards will be furnished for these selections.
- f. The officials for the state tournament will be selected by the state secretary.

3. TRACK

- a. Elimination will be by regions.
- b. In all track and field events the 1st, 2nd, and 3rd place winners in each region will qualify for the State Meet.
- c. No contestant may enter more than three individual events and the relay.

4. TENNIS

- a. Elimination will be by regions.
- b. The winning singles player in each region will qualify for the State final tournament.
- c. The winning doubles team in each region will qualify for the State final tournament.

5. RIFLE

- a. Eliminations will be by regions.
- b. The winning rifle team (5 men) in each region will qualify for the State final tournament.
- c. In any case where the high scoring individual in any region is not on the winning team, such individual will qualify for the State final match to compete for individual honors.

6. GOLF

- a. Eliminations will be by regions.
- b. The winning golf team (4 men) in each region will qualify for the State final tournament.
- c. In any case where the low scoring individual in any region is not on the winning team, such individual will qualify for the State final tournament to compete for individual honors.

7. BASEBALL

- a. Plans for the baseball eliminations will be announced by the State Secretary.

MEETINGS

- a. There will be three regular meetings of the District-At-Large, Class AA, each year.
- b. The first regular meeting will be held at noon on the date of the Tech-Georgia football game at such place as may be designated by the State Secretary.
- c. The second regular meeting will be held at noon on the day of the semi-finals of the State Basketball tournament at such place as may be designated by the State Secretary.
- d. The third regular meeting will be held at the time of the Spring State Meet at such time and place as may be designated by the State Secretary.
- e. Special meetings as may be necessary may be called by the President of the District-At-Large, Class AA, by written notice to each school through the office of the State Secretary.
- f. Any proposed legislation is to be presented by the second regular meeting and action on such legislation will be taken at the third regular meeting.

Standards for Officials

Georgia High School Association

For the season 1951-52

Any official must be at least 21 years of age and must not be a high school student.

Officials will be placed in three classes, REGISTERED, APPROVED, and CERTIFIED.

REGISTERED OFFICIALS

1. As soon as satisfactory references have been received on a completed application, the official will be classified as REGISTERED.

APPROVED OFFICIAL:

1. REGISTERED at least one year.

2. Have worked as an official in at least 3 football and/or 6 basketball games during the previous season with an average rating of not greater than 3.
3. Have made an examination grade of at least 75% on examinations in rules of play during the year for which approval is requested.
4. Have attended at least one regional or district rules interpretation meeting, or two local unit rules interpretation meetings for the year for which approval is requested.

CERTIFIED OFFICIAL

1. Have been APPROVED for at least one year.
2. Have had at least four years experience in the sport in which certification is requested or have served two years as an approved official.
3. Have a rating grade for the previous year in the sport for which certification is requested not greater than 2.
4. Have made an examination grade of at least 85% on examination in rules of play during the year for which certification is requested.
5. Have attended at least one regional or district rules interpretation meeting, or two local unit rules interpretation meetings for the year for which certification is requested.

After an official has received a CERTIFIED rating he shall continue to receive that rating each year, provided he attends at least one regional or district rules interpretation meeting or two local unit rules interpretation meetings for the year for which certification is requested, provided his average daily ratings for games worked the previous year is not greater than 2.

An official on the CERTIFIED list whose average ratings is greater than 2 but not greater than 3 for the games worked the previous year will be transferred to the APPROVED list.

The Georgia High School Association may cancel an officials rating for cause.

It is mandatory that all District and State Basketball Tournament games be played with a minimum of two officially dressed basketball officials who are registered under the GHSA plan for the registration of officials or with the State Association of another State.
