From the Secretary's Desk

ANNUAL DUES—Annual membership dues are payable to the secretary of the District in which the school is located. The membership year runs from October 1st to October 1st. Dues which are paid on or before October 1st receive a discount. (see section 1, item 3).

TEACHER-COACH RULE—The authorization for the waiver of the Teacher-Coach rule (section 1, item 7) is still in force. In a case where a school cannot secure a regular certified teacher as a coach, application for waiver should be made to the executive committee of the district in which the school is located. The committee is authorized to waive or not to waive as it may see fit. In any case where a waiver is authorized the school assumes full responsibility for the actions of the coach employed.

DISCUS—The official high school discus has been adopted for the use of GHSA schools in all contests. Specifications on this discus are:

Weight: 3 lbs. 9 ozs.—Diameter: 8.25" — Core: 2" in diameter and 1 5/8" thick; Thickness 1/4" from perimeter: .48"

2½ UNITS CREDIT—A pupil is eligible for only three years of participation after he or she has earned 2½ units of credit. While a pupil can still participate four years the pupil is eligible for only three years of participation after earning 2½ units. In effect this means that a pupil has only three years of participation after completing the first year of high school for which credit is given. (Sec. tion 1, item 15).

CHANGE TO 12th GRADE—If a school changes from an 11-grade system to a 12-grade system, those pupils who were in the 11th grade the year preceding the change are ineligible for further compensation. (Section 1, item 16).

AGE LIMIT—Effective in 1946-47 the age limit for participation will be 19.

TENNIS—District and State Tennis tournaments for Class B and Class C will be played in the Fall of the year. (See announcements, page 2). Class A may set the dates for their tournaments as it sees fit.)

GAME CONTRACTS—In the past several years there have been a number of games cancelled without mutual consent. Under the regulations in Section 2, item 20, in any case where a properly executed game contract is cancelled except by mutual consent, the offending school shall be suspended for one full calendar year from the date of such cancellation. The GHSA has a supply of contract blanks. Those may be secured from your District Secretary or the State Secretary, Schools are urged to use these game contract forms so as to have a definite record in writing.

CHANGES IN ADMINISTRATIVE SETUP—At the last annual meeting of the State Executive Committee it was the unanimous decision based on the report of a special committee that had thoroughly canvassed the State, that the program of the Georgia High School Association should be expanded so as to render more service to its member schools. Steps have been taken by the State Committee to initiate these services. Part of the work will be included this year and part will be added next year.

All original rulings as to eligibility will be made by the State Secretary instead of the District Vice Presidents. All original rulings on matters of protest or investigation will be made by the State Secretary. This has been done to insure uniformity over the State. Local district control has been retained in that any appeals from original rulings will follow the regular channels as has been done before—district committee, state president, state executive committee.

Clinics will be held this year to instruct officials to football, boys basketball, and girls basketball rules.

A central eligibility file will be established this year in the State Office. This necessitates a change in the method of filing eligibility blanks. Two copies of the eligibility blank will be mailed to the State Secretary instead of to the District Secretary. (Section 2, item 6) It will be necessary the first time a pupil's name appears on an eligibility list to file an individual information card for that pupil. After an individual card has once been filed, no further individual card will be necessary for that pupil. This will simplify the work of the local school and at the same time will give an accurate record on each player. Eligibility blanks and individual sheets may be secured from your District Secretary or the State Secretary.

Efforts will be made to keep each school better informed of the

GHSA plans through mimeograph bulletins and other publications. Each school will be furnished a copy of the "Southern Coach and Athlete" each month. In addition to the Georgia items of interest this magazine contains information in regards to the athletic activities of other Southern States and a variety of other athletic information.

Each school has been mailed an information sheet requesting the names and addresses of school officials, the name of the person to whom correspondence and magazine subscription should be mailed. This sheet also contains a section on which each school may indicate its choice of rule books. A large number of these information sheets have not been returned. It is impossible to get the material in the proper hands without a correct mailing list. If you are not receiving the various materials, advise the State Secretary.

In order to meet the increased costs of operation the financial structure has been revised. In the past football has not had to carry any of the load while basketball has had a large share. Under the current plans football will bear a part of the expense. This is outlined fully in Section 2, item 4. Payments for football are to be made to the District Secretary within five days after the game is played.

RULE BOOKS—Each school is entitled to three rules publications without charge. These are mailed to each school when the information sheet is returned showing the choice of rule books. A school may select from the following:

Football Rule Books _____available now Boys Basketball Rule Books ____available now Girls Basketball Rule Books ____to be shipped after Nov. 1 Track Rule Books ____to be shipped after Nov 15

Each school makes its own choice—you may select three of the same book, or two of one and one of another, or one each of three different books. Additional copies of the rule books may be purchased at the prices shown on page 2 of this bulletin.

TRACK—The mile run has been added to the list of track events for the District and State Meets with the restriction that no contestant may enter ever one event 440 yards or greater.

ATHLETIC INJURY INSUURANCE—The athletic injury insurance plan has been explained to give greater coverage. Coverage can be obtained for the entire year or for the individual sports at a low cost. Information will be mailed by the State Secretary upon request.

Constitution

ARTICLE 1-Name of the Organization

This organization shall be known as the Georgia High School Association.

ARTICLE- II-Object of the Organization

The object of this organization shall be the promotion of education in Georgia from a mental, physical and moral viewpoint; to promote the study of public speaking; to standardize and encourage athletics; and to promote appreciation for music, home making and other cultural arts through Districts and State Contests.

ARTICLE III—Membership

- Sec. 1. Schools Eligible for Membership—The Membership of the Georgia High School Association shall consist only of schools that are accredited by the Georgia Accrediting Commission.
- Sec. 2. Grouping of Membership by Size—The membership of the Association shall be divided into three groups, as follows:
 - Class A, composed of eligible private boarding schools and eligible high schools, with an A. D. A. of 800 or more.
 - Class B, composed of eligible high schools with an A. D. A. of between 125 and 799 students.
 - CLASS C, composed of eligible high schools with an A. D. A. of less than 125 students.
- Sec. 3. GROUPING, HOW DETERMINED—The classification of schools into various groups shall be based on the Average Daily Attendance (A. D. A.) secured from the State Department of Education as of July 1st annual report. The A. D. A. of July 1st shall determine the classification of a school for the following school year. In case of a consolidation the A. D. A. of the schools consolidated shall be combined to determine the classification.
- Sec. 4. GROUPING OF MEMBERSHIP BY DISTRICTS—All schools shall be members of a district organization in the Congressional District in which they are located, with the exception of the Class A schools which for the District-at-Large.
- Sec. 5. COLLEGES—Junior Colleges and preparatory departments of colleges are ineligible for membership in this Association.
- Sec. 6. JUNIOR HIGH SCHOOLS—Junior High Schools are ineligible for membership in this Association.

- Sec. 7.—TRANSERS FROM DISTRICT—Any eligible school which is located near the border of a district and because of its location wishes to be transferred to membership in a neighboring district, may do so on consent of the District Committee from both districts and the state president, provided no rules are violated otherwise, and provided the transfer of membership is made before October 1st.
- Sec. 8. MEMBERSHIP IN ANOTHER ASSOCIATION. A school is ineligible for membership in the Georgia High School Association if it is or becomes a member of any association whose Constitution and/or By-Laws conflict with those of the Georgia High School Association.

ARTICLE— IV—How Governed

- Sec. 1. STATE OFFICERS. The State officers of this Association shall consist of a President, a 1st Vice-President, a 2nd Vice-President, and a Secretary-Treasurer. Those with each District President, and one member of the faculty of the College or University where the state meet is held, and the State High School Inspector shall constitute the State Executive Committee.
- Sec. 2. DISTRICT OFFICERS. Each district shall elect a President, a Vice-President, a Secretary-Treasurer, and three other committeemen who shall be from Class B and C in proportion to the number of member schools from each class, no two shall be from the same school. These officers shall compose the Executive Committee in their district.
- Sec. 3. DUTIES OF OFFICERS. The duties of the various officers and committees shall be those usually devolving upon such officers and committees. It is specifically the duty of the State Executive Committee and the District Committee to seek at all times to educate the school officials under their jurisdiction concerning the Constitution and By-Laws of this Association, and at the same time to check vigorously any practice or violation of the rules by exercising the full penalty for such violations, if it seems necessary.

Sec. 4. ELECTION OF OFFICERS.

(a) A President, a 1st Vice-President, a 2nd Vice-President, and a Secretary-Treasurer shall be elected as State Association officers for the next school year at the annual meeting of the Georgia High School Association each year at the time of the State Meet. Only each District President or his representative and other members of the State Executive Committee shall vote.

- (b) A President, a Vice-President, and a Secretary-Treasurer and three committeemen shall be elected as officers for each district at any Spring Meeting. Each member school have only one vote.
- (c) Vacancies occurring on committee shall be filled by the committee until regular election time.
- Sec. 5. AUTHORITY. (a) All questions of eligibility, or of any other matters subject to investigation, must first be submitted to the State Secretary, who shall make a ruling thereon after hearing the evidence of both sides. If either the defendant or the plaintiff is not satisfied with this decision, appeal may then be made to the District Executive Committee. In the event that the State Secretary fails to act within one week, an appeal may be made direct to the District Executive Committee either through the President or the Secretary. After hearing the evidence submitted by both sides, the District Executive Committee shall render a decision in the matter. If either party is still dissatisfied with the decision or if the District Executive Committee fails to act within one week, appeal may then be made to the President of the Georgia High School Association, who shall hear the evidence of both sides and render a decision. If either party is still dissatisfied, either party may then appeal to the State Executive Committee, provided the party or parties appearing shall pay the entire expenses of the State Executive Committee when called together for this urpose. The State Executive Committee shall then hear the evidence of both sides and render a verdict. This last appeal shall be final and anyone seeking redress through any other channel shall forfeit the membership of their school in the Georgia High School Association for one year. No other method of appeal shall be held valid, and any appeal made must begin with the first step outlined and not eliminate any step until reaching the final court of appeal, the State Executive Comrhittee.
 - (b) The State Secretary shall be authorized to interpret rules.
- Sec. 6. VOTE. Each school shall have one vote in a District meeting and each District shall have one vote in a State Executive Committee meeting through its President or officer next in line. If no officer of a district attends the State Executive Committee meeting, the District President shall have the power to appoint some school man from the membership of his district to represent him in this particular meeting.
- Sec. 7. AMEND CONSTITUTION AND BY-LAWS. It shall take a two-thirds vote of the State Executive Committee to amend the Constitution. A majority of votes shall be required to amend the By-Laws. Changes shall not go into effect until the beginning of the next school year. Any proposed changes in the Constitution must

be submitted to the Secretary in writing by March 1. These proposed changes shall be submitted by the State Secretary to each District President not later than April 1st.

- Sec. 8. ANNUAL MEETING. The Georgia High School Association shall meet in executive session each year at the time and place of the State Literary Meet, at such an hour in such a conference room as the President may designate.
- Sec. 9. SUSPENSION OF A SCHOOL. The District Executive Committee has authority to suspend any school under its jurisdiction from membership in the Association on sufficient evidence of violation of the rules of the Association, with the provision that the suspended school may appeal in the manner presented in Art. IV. Sec. 5, except that the appeal must be made directly to the State President from the decision of the District Committee. The penalty may be fixed as suspension for the remainder of the playing season and for forfeiture of games or events won, and/or the suspension from membership for twelve months, at the discretion of the committee.

ARTICLE V—General Provisions

Sec. 1. REPORTS:

- (a) The Principal or Superintendent of each member school shall make reports to the District and State Secretaries at the times prescribed by the By-Laws and in the manner called for, and also such other reports as may be called for by the District or State Committee.
- (b) The Secretary of each District, or his representative, shall make a written report of the financial condition of his district organization, and of all activities in his district naming champions in football, basketball, track, if any be declared by the District Committee, and all other district activities, to the State Executive Committee at the annual meeting held at the time of the State Literary Meet.
- (c) All reports of a District Secretary to the State Executive Committee concerning entries in the State Basketball tournaments, and the State Meet or concerning any routine matter pertaining to the Georgia High School Association, shall be addressed to the State Secretary. These reports shall be filed in the office of the State Secretary for future reference, it will not be necessary at any time for an individual school to make a report to this office as all reports must come from the District Secretary.
- Sec. 2. CONTESTS. Each district may hold annual contests in reading, declamation, music, debate, spelling, essay, home econo-

mics, athletics, typing, shorthand, agriculture, and other forms of contests which may be authorized by the State Executive Committee, calculated to promote the cause of education, on a date in April to be announced in this Bulletin under the rules governing the State and District Meets. Schools in Class A may enter the literary contests of Class B schools, by paying the fees set by the District Committee, but must conduct their own athletic meet. Winners in these district contests may be sent to the annual State Meet both in athletics and literary events.

Sec. 3. TREASURER. The Treasurer of each district is required to make an itemized statement of the income and outgo of all funds to the District Executive Committee. The State Treasurer is required to make a similar statement to the State Executive Committee. When a new Treasurer is elected, any balance in cash or bank account must be turned over to the new officer immediately.

Sec. 4. OFFICE. The permanent office of the Georgia High School shall be the office of the State Secretary-Treasurer. From this office shall be sent out bulletins, and all other routine blanks and forms. Requests for such material shall be addressed to the State Secretary. The person in charge of the State Office shall have charge of making all arrangements for holding and conducting the State Meets and Tournaments.

By-Laws

- Sec. 1. A student is eligible to represent his or her school of all classifications unless otherwise noted, in interscholastic contests:
 - Item (1) Who is a regular student taking four units of work.
 - Item (2) Who is passing at least three units of work.
 - Item (3) Who is not a special student.
 - Item (4) Who has earned at least three Carnegie units last year in school.
 - Item 5() Who was properly registered within 15 days of the beginning of the semester or quarter in which the event takes place.
 - Item (6) Who is an amateur.
 - Item (7) Who is not playing on a school team and some other team during the same period of time.
 - Item (8) Who has made up enough deficiencies so that he or she is passing in at least three subjects, provided no student shall be allowed a re-examination within seven calendar days after failing in two or more subjects. Also, no subsequent examination shall be given within seven calendar days after falling on any re-examination.
 - Item (9) Whose deportment satisfies the requirements of the school authorities.
 - Item 10) Who has not earned 16 Carnegie high school units. (Exception for Class A Boarding Schools, see Sec 5.)
 - Item (11) Who is not a four-year or a senior high school graduate. (Exception, Class A Boarding Schools, see Sec. 5.)
 - Item (12) Who hasnot played four years of high school competition in that sport or event.
 - Item (13) Who has not yet attained his or her twentieth birthday, before the beginning of the respective playing season. Effective in 1946-47 the age limit will be 19 instead of 20.
 - Item (14) Who is not a migrant student of less than a year's standing.
 - Item (15) Who has not played three years of high school competion in that sport or event after earning 2½ units of credit. (This means that while a pupil may participate for four years, only three years of participation will be allowed after 2½ units have been earned.)

- Item 16) Who was not a member of the 11th grade of a school in the year preceding that school's change to a 12-grade system.
- Sec. 2. A School to be eligible to participate in interscholastic contests in this Association:
 - Item (1) Shall be a member of the Georgia High School Association.
 - Item (2) Shall be an accredited senior high school
 - Item (3) Must pay annual dues to the District Secretary-Treasurer. It is the responsibility of the individual school to see that dues reach the District Secretary-Treasurer.

Dues paid on or before OCTOBER 1 will be:

Class A \$20.00 Class B 10.00 Class C 7.50

Dues paid after OCTOBER 1st will be:

Class A \$25.00 Class B 15.00 Class C 12.50

- Item(4 Shall pay to the District Secretary-Treasurer within five days after each home contest in football the amount designated according to receipts. (See Section 3, item 4.)
- Item (5) Shall be governed by person or persons who believe in fairness and honesty, an evidence of which shall be the strict observance of all rules and regulations in regards to eligibility of contestants representing their school.
 - Item (6) Must not have been disqualified as a member school for violation of the Constitution or By-Laws within one year.
 - Item (7) Shall employ no one to coach who is not a full-time teacher, certified by the State Department of Education, and receive his or her entire pay from the Board of Education that employs him or her. (A coach not employed by the Board of Education but who lives in the community and earns his living in some other manner but gives his time to the school is strictly in violation of this rule.)

- Item (8) Must abide by all rules of the State organization and also the District organization when the rules of the District organization are not in conflict with the rules of the State organization.
- Item (9) Shall play no independent team or teams of other schools not a member of this or some allied organization, except college freshmen and then not in football. Exceptions:
 - 1. Member schools may schedule and play junior high schools.
- 2. Member schools may schedule and play ameteur baseball teams provided that there is no objection on the part of the school authorities where the independent team is located and that in no case will an independent team use any boy enrolled in a high school if there is objection by local school authorities.
 - 3. Member schools may participate in interscholastic contests with member schools of a private non-state association provided that all transfer pupils of the member school of the private school association be eligible only after a full year's attendance at the private school concerned.
- Item (10) Must make out complete eligibility papers and forward TWO copies to the STATE SECRETARY before the first contest for the year in that sport. Each game played prior to the filing of TWO copies of the eligibility list with the State Secretary shall be forfeited, and in addition thereto, if the eligibility list is not filed with the State Secretary prior to the first contest of the year in that sport, a fine of \$2.50 per contest shall be levied upon the school for every contest played until such eligibility list is filed; payments of fine or fines for any delayed filing of eligibility list shall be made to the District Secretary. Failure to pay such fine as may be levied shall prohibit the school from entering any contest. (In basketball in any case where a delay occurs in the filing of an eligibility list, for the purpose of culating the fine, in case where a school plays a double header basketball game, this shall be considered as a single contest.) Deadline for payment of any fine levied shall be the deadline as may be set by the district committee concerned.
- Item (11) Must make out complete eligibility papers and exchange with competing school at least three days before each contest.
 - Item (12) Shall allow only one football game per week by the same team on the season average, and only two games

- per week in baseball, by the same team, except in tournaments, and shall allow only two basketball games per week by the same team. (Exception, tournaments and Class A.)
- Item (13) Shall allow no basketball team to play more than thirty basketball games during the season. (This does not include District and State Tournaments).
- Item (14), Shall allow its basketball team to enter only one tournament in addition to the District Tournament. (The State Tournament is considered to be a continuation of the District Tournament in which a team participates.)
- Item (15) Shall allow no student to switch from one team to another so as to engage in more than one football game per week or two basketball games per week.
- Item (16) Shall provide strict physical examination by a competent physician of each and every contestant at the beginning of each season in each sport.
- Item (17) Must fill out the blanks prepared by the State Executive Committee provided for the District Meet one week before that event and forward same to the District Secretary.
- Item (18) Shall not enter any inter-district basketball tournement unless such entry is approved by the District Executive Committee.
- Item(19) Shall in no case permit spring football practice to continue longer than six consecutive calendar weeks.
- Item (20) Shall not cancel any game contract that has been properly executed without the agreement and consent of the other school concerned. Any school failing to carry out a game contract shall be suspended for one full calendar year. (This means that if a cancellation should be made on the last game of a football schedule, that the suspension would continue up to and include the corresponding date of the next calendar year.)
- Item (21) Shall not compete in any interstate tournament or meet in which three or more school participate, nor in any interstate contest between two schools which involves a round trip exceeding 600 miles, unless such event has been sanctioned by all interested state associations through the National Federation of State High School Athletic Associations.

- Section 3. Each District organization, through its Executive Committee or proper official, or in general session:
- Item (1) May pay its Secretary-Treasurer a salary of \$50.00 or more a year.
 - Item (2) Shall pay to the State Secretary as dues for those schools whose dues have been paid on or before October 1st on the following basis:

For those schools whose dues are paid after October 1st an additional \$25.00 shall be paid for each school. The first report from each district is due in the State Office by October 10th.

Item (3) Shall collect and pay 5 per cent of the gross receipts of all basketball tournaments held within the District to the State Treasurer within five days after the close of the tournament, these funds to be used to defray the expenses of the State Association. (Exception, any basketball tournament confined strictly to schools in the same county and held after the District tournament have been completed, shall not be liable for 5 per cent of the gross receipts.)

Shall collect through its District Secretary and pay to the State Secretary the amount designated for each football game played in its district according to the following scale and regulations:

Any Class—10% of the gross receipts of all play off and post-season games.

- 1. The home team is responsible for payment.
- 2. In calculating gross gate receipts, in a case where season tickets are sold, the amount received from season tickets shall be divided by the number of home games and this average amount added in with the gate receipts of the game to determine the gross receipts for that game.
 - Payment shall be made to the District Secretary within five days after the game is played.
- 4. In the case of a game which is not classified as a home game for either school participating, the school or organization sponsoring such game shall be responsible for payment. It is the responsibility of each school participating in such game to make it clear to the sponsoring agency that payment as set up in the scale is a part of the condition under which the game is played, and that in the event that the sponsoring agency does not make payment each school participating in such game will be equally liable for one half of the payment according to the schedule.
- 5. In case of a game between schools of different classification, the classification of the home team shall be used as the basis for determining the amount to be paid.
- Item (5) Shall provide suitable medals and trophies for individual winners and cups or banners for winning schools in Districts competition.
- Item (6) May assess sufficient fee for District Meet entrants to pay expenses of judges, printing, etc., and expenses of delegates to the State Meet.
- Item (7) Shall play girls' basketball under girls' rules and on a two-division court.
- Item (8) Shall allow no tournament in which member schools participate to be held in its territory except on permission of the District Committee and on the assurance that the tournament will be conducted according to the regulations of this Association. Penalty for violation of this rule is found in Art. IV. Sec. 9, of the Constitution and By-Laws.
- Item (9) Shall make such rules as may be necessary to successfully operate the District organization, provided the rules are not in conflict with the rules of the State organization.

- Item (10) Shall determine the place or places for the District Meet and basketball tournaments, provide for admission fees, division of funds with local school, and other details necessary for the successful operation of the Meet and tournaments.
- Item (11) Shall, through its Secretary, certify as to the winners in the District basketball tournament ten days before the State Tournament, and as to the winners in all events of the District Meet ten days before the State Meet, to the State Secretary. Eligibility of contestants as well as the names of the school they represent shall be included in the report. The full name of each contestant shall be given.
- Item (12) (a) Schools having an agricultural department are permitted to have F. F. A. basketball teams and to hold tournaments provided the rules and regulations concerning the eligibility of students and the conducting tournaments as outlined in the By-Laws of the Georgia High School Association are strictly observed. The District Committee in whose area the school is located and where the tournament is held shall have jurisdiction concerning any matter pertaining to eligibility or the tournament. (b) Schools that are not members of the Georgia High School Association, but that have an agricultural department, may be permitted to participate at games or tournament conducted for or by F. F. A. basketball teams, provided the principal or superintendent of the non-member school shall apply to the District Committee for permission to play and agrees to abide by the rules and regulations concerning eligibility of students as outlined in the By-Laws of the Georgia High School Association.
- Item (12) Shall determine if schools within its District may enter any approved inter-district tournaments.
- Item (14) Shall furnish a copy of the complete results of all district contests held in and for the district to each participating school in the district.
 - Sec. 4. The State organization through its Executive Committee ore proper official:
- Item (1) Shall pay its Secretary-Treasurer according to the budget adopted by the State Executive Committee.
- Item (2) Shall provide an adequate place for the State Basketball Tournaments and the State Meet.

- Item (3) Must provide an official receipt for all dues and fees received from District Treasurer so that they may submit proper showing for all monies handled by them to the District Committee at end of the year.
- Item (4) Shall pay the State organization officials five cents permile, one way, as traveling expenses when on official business.
- Item (5) Shall determine if any Inter-District or State Tournaments shall be allowed and determine the place or places where they shall be held. No Inter-District tournament shall be authorized unless such tournament has been approved by the District Executive Committee in whose district the tournament is to be played.
- Item (6) Shall provide eligibility blanks to each and every member school in sufficient quantities to supply their needs for the year. These blanks shall have spaces to include the name, exact date of birth, grade, and number of years on team not including this year, for each individual on a team.
- tem (7) Shall determine in June or any subsequent date what approved contests shall be held during the coming year.

 All contests of whatever nature are forbidden in all member schools where such schools enter into contests with other schools for prizes or awards unless the sponsor of such contest shall first secure the approval of the State Committee to hold such contests. Member schools who enter such unapproved contests are to be punished the same as for any breach of the rules of the Association.
- Sec. 5. All Class A schools shall be governed by the same rules as other schools, with the following exceptions:
 - Item (1) A graduate of an accredited high school or a student who has earned 16 or more Carnegie high school units may represent a Private Boarding School when playing another Private Boarding School.
 - Item (2) Class A schools may play colloge freshmen or junior colleges in any sport desired.
 - Item (3) The definition of an amateur, though prescribing that a student cannot accept compensation for his athletic service or ability, does not mean that he cannot accept a scholarship to a school which will cover his actual school expenses and thus enable him to secure an education.

- Item (4) Any Class A school of the Georgia High School Association that fails to postmark football eligibility blanks containing information required by the Georgia High School Association to the State Secretary by October 1st shall be suspended from the Association for one year effective on the day of the District-at-Large Meeting about December 1st of that year. All games won or lost during the season shall be defaulted. Contracts for other contests between the suspended school and other Georgia High School Association Schools shall be abrogated for the duration of the suspension. The State Secretary shall instigate proceedings against the offending school.
- Item (5) An exception to the migratory rule shall be made to allow public high schools of Class A to play Private Boarding Schools of Class A under conditions agreed upon by the schools concerned. (This exception does not apply when public high schools of Class A are playing each other and when any Class A school is playing a Class B or C school.)
- Item (6) Class A Boarding Schools which are members of the Mid-South Association will be permitted to enter any tournament or meets conducted by that Association in accordance with its rules and regulations when that that tournament or meet is confined to member schools of the Mid-South Association.
- Item (7) An exception to Section 2, item 12, shall be made for Class A school in basketball when a Class A school travels from one city to another and plays two class A schools on the same trip.

Sec. 6. Definitions:

- Item (1) AN AMATEUR is defined as one who has never violated his or her amateur standing by receiving money, tuition, board, gifts worth more than \$10.00, or pay of any description as compensation for playing on an athletic team, or playing under an assumed name. (Note: To receive any of the above will be interpreted as subsidization and no other view will be accepted.)
- Item (2) A UNIT OF WORK is a course of study for which one Carnegie unit will be allowed if completed.
- Item (3) INTERSCHOLASTIC COMPETITION IN THIS ASSO-CIATION is interpreted to mean engaging in contests

with member-schools only, or with college freshmen in all sports except football. Inter-scholastic competition with non-member schools is forbidden.

- Item (4) MIGRATORY RULUE-Any pupil who changes school is a migrant pupil. A migrant pupil must remain in a school to which he or she has transferred one full calendar year before he or she may become eligible. Students from accredited and/or non-accredited high schools and/or students from Junior high schools attending schools other than the one to which they are assigned by the County or City Board of Education are migrants, unless and until they are made eligible by one year's attendance. A student who transfers from a member high school to a private or boarding school or from a private or boarding school to a member high school is not eligible until after one full calendar year of enrollment has elapsed after transfer. A student who transfers from one high school to another because his parents move or transfer their residence is eligible in the high school of his parent's residence provided he meets all other requirements.
- Item (5) REGISTRATION means the enrolling of a student in any manner.
- Item (6) A SPECIAL STUDENT is a person taking work in a school which does not carry credit in terms of Carnegie units; or one who is repeating work already passed; or, a person who is allowed special privileges and is not required to fulfill all duties that pertain to a regular or normal student.
- Item (7) A SCHOOL YEAR is defined as attendance in a high school for a period of 20 days or more, provided the student has not participated in any competitive interscholastic contests; or as attendance in high school one day if the student engages in some interscholastic contest on that day.
- Item (8) A YEAR'S PLAY constitutes the entering of competitive play in a sport by a student in any manner, either as a substitute for just one play or more; or the playing of the entire season as a regular player on the team. Participation in any interscholastic spring football game shall constitute a year's participation for all participants.
- Item (9) A QUARTER shall be considered a period of three months, during which time a student may not earn more than two Carnegie Units.

Athletics

TRACK AND FIELD EVENTS

- Sec. (1) The rules for track are made by a joint commtitee.

 Those rules applying to colleges are published by the A. S. Barnes Co.; those rules applying to high schools are published by the National Federation of State High School Athletic Associations. The National Federation Rules will be the guide for Classes B and C with the exceptions as may be found in special regulations listed below. The rules for Class A will be those adopted by the Class A Executive Committee subject to any special regulations as may be adopted by the Class A Executive Committee.
- Item (1) Each school may have only one contestant in each event except relay. No contestant may enter more than two events and the relay, and in no case may any contestant enter more than one event 440 yards or greater.
- Item (2) There shall be twelve track and field events as follows:
 100-yard dash, 12 pound shot put, 220-yard dash, running high jump, 120-yard low hurdles, running board jump, 440-yard dash, half-mile, pole vault, discus throw (high school weight), half-mile relay (four men), mile run. The relay teams in the State Meet may be made up of the representatives from the districts at large, provided each man in the relay is a representative in some other track or field event.
- Item (3) In case of a tie for first place in any district track or field event, the contest must be continued or reheld until a representative for the State Meet is determined. In case of a tie in the original contest the points shall be evenly divided among the tying contestants. The continued or reheld contest shall carry no points. In case of a tie in the State meet the tie shall stand, and the points will be divided among the tied contestants.
 - Item (4) A District Winner shall be decided in the State Meet.

 The high point trophy shall go to the school which scores the most points whether said school is in the winning district or not.
- Item (5) In the shot put, discus throw, and broad jump events the giving of quality and final throws is optional. If

the District Executive Committee wishes to do so, it may dispose with qualifying trials and allow each contestant in any of these three events only the three trials, only the best of the three trials to count.

Item (6) The following events shall be held in the order named at District Meets (exception when heats are necessary); mile run, 100-yard dash, shot put, 220-yard dash, running broad jump, hurdles, running high jump, 440-yard dash, half-mile, pole vault, discus, half-mile relay.

- Item (7) The State Meet will be scheduled as a one or a two day meet according to the schedule announced prior to the State Meet. If the meet is a one day meet the trials will be held in the morning with the finals in the afternoon or night. If the meet is a two day meet, the trials will be held one day and the finals the next. In any State Meet in which the number of entries is under the maximum, the qualifying and finals may be run the same day, provided notice that such will be done is given prior to the beginning of the meet.
 - Item (8) Four places will be counted in both District and State Meets. First place shall count 7 points; second place, 6; third place, 3; fourth place, 1.
- Item (9) (a) In all field events where there are qualifying jumps, throws, or vaults, five men will qualify in each event for the finals. In any field event in which there are eight or less entries, the qualifying session may be eliminated and the final session substituted, in which case each contestant will be given six tries.

- (b) In the shot put and the discus throw each contestant will be allowed four throws in the qualifying session. In the final session each contestant will be allowed three throws. Throws made in the qualifying session will stand for record in the finals.
- (c) In the broad jump each contestant will be allowed four jumps in the qualifying session. In the final session each contestant will be allowed three jumps. Jumps made in the qualifying session will stand for record in the finals.
- (d) In the qualifying session in the pole vault and high jump the last five remaining shall qualify for the finals.
- (e) In any running event in which there are six or less entries, the finals may be substituted for the qualifying session.
- (f) All contestants in the Sttate Meet are expected to report on the field not less than 30 minutes prior to the beginning of the meet.
- (g) Schedule of Events for Qualifying Session:

- 2. Trials of the 120-yard low hurdles _______2:30 p. m. (Two heats, qualify the first and second in each heat and the faster third if five fights of hurdles ar available; if six fights of hundles are available, qualify the first three in each heat.)
- 3. Trials of the 100-yard dash ______2:40 p. m. (Two heats, quality first three in each heat.)
- 4. Trials of the 440-yard dash ______2:50 p. m. (Two heats, qualify first three in each heat)
 - 5. Trials of the half-mile run _____3:00 p. m. (two heats, qualify first three in each heat)
 - 6. Broad jump (Qualify five) _____2:50 p. m.
- 7. Trials of the 220-yard dash ______3:10 p. m. (Two heats, qualify first three in each heat)
 - 8. Discus—follow immediately after conclusion of shot put. (Qualify five)

(The time schedule for the final session is subject to change. In any case the events will be called in the order given and the same time intervals will elapse between events).

- Sec. 2. TENNIS is a District and State event separate from track and will not count for points in winning the track cup in the District or State Meet. The District winners, who will be certified by the District Secretary at the same time as he makes his report to the State Secretary for winners of the District Meet, will be eligible to go to the State Meet District elimination tournaments will be arranged by the Executive Committee of the respective districts. Tennis requires two players for the doubles and one player for the singles. A boy or a girl may not participate in both singles and doubles. Four boys will constitute a boys' team and four girls will constitute a girls' team making a total of four per team from each school. There will be no mixed teams. Four certified players may be eligible to play in any elimination or final matches at discretion of coach.
- Sec. 3. GOLF. Golf is a State Event. It is open to B and C schools. Contestants in golf will be certified direct to the State Secretary by the local superintendent or principal. In any case where there are entries from less than six schools, no golf tournament will be held. The State Golf tournament this year will be held at Macon on October 8, 1945. Entries for the tournament must be filed not later than September 27, 1945.

Sec. 4. Dates for District and State Tournaments and Meets

- (a) The State Golf tournament will be held at Macon, Ga., OCTOBER 8, 1945. All entries must be filed with the State Secretary not latter than midnight of SEPTEMBER 27, 1945.
- (b) All District Tennis tournaments must be completed prior to SEPTEMBER 30, 1945. Reports of winners must be filed with the State Secretary not later than midnight, OCTOBER 2, 1945.

- (c) State Tennis Tournaments—B and C— will be held at Mercer University, Macon, Georgia, OCTOBER 8 AND 9, 1945.
- (d) The State Basketball tournaments will be held at Mercer University, Macon, Georgia.
- (e) The Boys State Basketball tournament will be played on MARCH 6, 7, 8, AND 9, 1946.
- (f) The Girls State Basketball tournament will be played on MARCH 13, 14, 15, AND 16, 1945.
- (g) All District Boys Basketball tournament must be completed PRIOR TO FEBRUARY 24, 1946 Report of winning team must be filed with the State Secretary not later than midnight, FEBRUARY 26, 1946.
- (h) All District Girls Basketball tournaments must be completed prior to MARCH 3, 1946. Report of winning teams must be filed with the State Secretary not later than midnight, MARCH 5, 1946.
- (i) All District Literary meets must be held the week-end of APRIL 12 and 13, 1946, and complete returns filed with the State Secretary not later than midnight, APRIL 18, 1946.
- (j) All District Track meets must be held the week-end of APRIL 19 and 20, 1946, and complete returns filed with the State Secretary not later than midnight, APRIL 25, 1946.
- (k) The State Literary Meet will be held at Mercer University, Macon, Georgia, APRIL 26 AND 27, 1946.
- (1) The State Track Meet will be held at Mercer University, Macon, Georgia, MAY 3, 1946. (May be extended through May 4).

FOOTBALL AND BASEBALL

Sec. 5. FOOTBALL.

Item (1) Member schools of the same classification may form conferences where four or more schools so desire. The schools may meet at a time and place agreed upon and form an association. Each member school shall have one vote in all sessions of the conference. A schedule shall be arranged where each school of the conference plays each other school at least one game during the season . . . exception, where the conference is large and such a plan would not be feasible then each school must play a representative schedule as recommended by this conference.

- Item (2) Each conference so organized must file with the State Secretary a copy of its Constitution and By-Laws. Each conference must file with the State Secretary a copy of its official conference football schedule.
- Item (3) If the schedule is arranged in such a way that a conference championship cannot be determined, one post season football game may be played to determine the championship of the conference.
- Item (4) In case of a tie in games won, then the conference may declare the tying teams equal champions of the conference.
- Item (5) After the conference schedule has been arranged the member schools may complete their schedules with other teams that are members of the Georgia High School Association or with teams of other states provided that they belong to their respective state associations.
- Item (6) No school may engage in a football game unless that school has had a minimum of two weeks practice.
- Item (7) All football games must be played under the National Federation Interscholastic Football Rules.
- Item (8) A member school shall allow only one football game per week by the same team on the season average. (By-Laws, Sec. 2, Item 11).
- Item (9) Spring football practice shall in no case continue longer than six consecutive calendar weeks.

Sec. 6. BASKETBALL:

- Item (1) No school shall participate in more than two games in basketball per week (exception—tournament play.)
- Item (2) No school may play more than thirty games of basketball with other schools during the basketball season. (This does not include District and State Tournaments.)
- Item (3) A school may permit its basketball teams to enter only such tournaments as have been authorized according to the rules and regulations of the Georgia High School Association.
- Item (4) All boys basketball games shall be played by the National Federation Basketball Rules. All girls basketball games will be played by the official girls rules published by A. S. Barnes Co. (Exception for play off of tournament games, see Item 8.)

- Item (5) Where two basketball teams have the same color of jerseys it shall be the duty of the home team to change colors in the interest of good sportsmanship. In tournaments where two teams have the same colors, both schools shall change.
- Item (6) The officials in all games shall have complete control over all features of the game. In District and State Tournaments the Committee in charge shall secure the services of a competent scorer. No team shall have the privilege of placing their scorer to check the official scorer at or near the position occupied by the official scorer. Often official scorers are materially hindered by others who call out the numbers of the offending players and otherwise distract the attention of the scorer.
- Item (7) A school may enter its basketball team in only one tournament in addition to the district tournament. (The State Tournament is construed to be a continuation of the District Tournament in which a team participates.)
 - (8) In as much as girls' rules do not provide for the playoff of a game, and since tournament play requires that a winner be determined, the following regulations shall be enforced for playing off the games in tournaments for girls. "In the event that the score is tied at the expiration of the regular playing time, after a rest period of three minutes an extra period of three minutes will be played. If the score is still tied, alternate rest periods of three minutes and extra playing periods of three minutes shall continue. The team which is ahead at the expiration of any extra period shall be the winner. At the beginning of any extra period the ball will be put in play by a jump at center between two for wards of opposing teams. Any team which refuses to play off a tie shall have the game forfeited to its opponent by the referee. Extra periods shall be construed to be continuation of the second half."

LITERARY EVENTS

Due to the fact that it has been possible to complete the details of the Literary contests, the Literary section has been left out of this bulletin. Another bulletin will be printed in November which will contain the information in regards to the Literary events.

The District Literary meets have been advanced on the calendar to correspond with the advance of the State meet date. In the past two years there has been much confusion in attempting to conduct literary and athletic events at the same time. There have been many cases where it has worked to the disadvantage of the contestants. This year the State Literary meet will not be held at the same time as the Track meet. See the announcemnts on page two of this bulletin for dates.

In all events which carry a time limit contestants will not be disqualified if they stop promptly when time is called. The contestant will be warned at the expiration of time.

In all district contests a representative for the State meet must be determined. Ties for first place in the District must be broken by a continuation of the contest or by reholding the contest. The points stand as made in the original contest and no points will be allowed in the continued or reheld contest. The regulation permitting all contestants typing for first place in an event to participate in the State meet has been revoked and only one representative will be permitted from each district in each event.

Listed below are some of the major changes in contests from last year:

Shorthand—A new contest for district and state meets.

Agriculture—Contests will be held in this phase of work if they can be worked out in time.

Reading—while the material for this year has not been selected, the material will not be limited to Shakespear.

One Act Play—The regulation barring religious plays has been eliminated.

Typing—District winners will compete at the State meet. Contestants will be responsible for furnishing own typewriters. The District and State contests will be a 15-minute straight copy test.

Essay-Topics will be limited to current events.

Declamation—This is a contest for boys only.





Sportsmanship

Your State Executive Committee at a recent meeting had placed before it several examples of poor sportsmanship. The sentiment of your Committee which feels that it expresses the sentiment of all schoolmen in the state is that it is a definite responsibility of the administrative officials of the school and the athletic coaches to promote and foster a spirit of good sportsmanship by extending in every way possible all courtesies to visiting teams, officials, and spectators; to educate your home town spectators and the pupils of your school so that they will conduct themselves in such a way that your locality and its school will build for itself a reputation for sportsmanship of the highest order.

The New Jersey State Interscholastic Athletic has placed in the hands of each of its member schools and article written by a principal of a New Jersey High School. With permission of the New Jersey Association this article is given below.

A Creed For Athletics

We talk a good deal about promoting international amity. Educators particularly are constantly and solely being enjoyed on the necessity of their educating young people, so that they may understand how vital it is for all nations to learn to live together in a spirit of good will. We are told again and again that our foreign affairs must be conducted in neighborly kindliness, if mankind is to survive.

Athletics are the chief "foreign affairs" of New Jersey schools; athletics in general are the means whereby groups meet, in friendly fashion, with other schools just as nations do in the dealings of commerce.

But while athletics, like commercial dealings, are competitive in nature, they are not war. They are, in fact, historically and biologically considered, nature's substitute for war. Viewing athletic contests from that angle, we shall find it important not to let the sense of rivalry and conflict develop in athletics to the point that dangerous violence flares up. If we expect to teach our young people international amity, it is well to begin on the playing field and in the gymnasium. There they must learn self-restraint, a code of honor in conflict, a willingness to concede merit to opponents and to give them fair opportunity to show their prowess, modest in victory, and an avoidance of acts that are barbaric rather than civilized. War has degenerated into a callous savegery that would appal Sioux Indians or Attila's Huns. Let's keep athletics on a loftier plane, as one way of redeeming mankind.

The situation is made either more difficult or easier, I don't know which, by the fact that, in general, it is not usually the actual players who offend. It is most frequently the bleachers. Often the worst culprits are adults—alumni or residents of a particular school district, who (through insulting shouts or cowardly blows while watching an athletic contest) vent a frustration or soothe a feeling of inferiority. Physical educators and coaches, along with the rest of the faculty of a school, must make it their function to educate all persons interested in athletics into a realization of the fact that athletics at its best is Chivalry—the modern name for which is sportsmanshiy.

From the Secretary's Desk

DISCUS—The official high school discus has been adopted for the use of GHSA schools in all contests. Specifications can be found in the Track rules book or on page 5 of the September bulletin.

ELIGIBILITY REPORTS—A central eligibility file has been established in the State Office. Two copies of the eligibility certificate (form E-2) are to be mailed to the State Secretary before the first contest of the year in the respective sport. The first time a pupil's name appears on an eligibility certificate, an individual information sheet is to be filed for that pupil—form E-1 After an individual sheet has once been filed for a pupil no further individual sheet will be needed as the record of that pupil will be kept up to date from the information contained on the eligibility certificate.

It has been evident from some of the reports received during football season that a number of schools are permitting the pupils to fill out the information sheets. If this is done, the sheet should be checked carefully by the head of the school for accuracy. If a duplicate information sheet is made by the school and kept in the school permanent record file it gives the school an excellent means of keeping its athletic record up to date.

State and District Meets

LITERARY EVENTS

- Sec. 1. The State Executive Committee and each district Committee, working under the rules and regulations set out in the Constitution and By-Laws of the Association, shall have entire charge of the operation of their respective meets, the selection of judges and officials for each event. They shall:
 - Item (1) Provide a time keeper in each event in which there is a time limit to be observed. It shall be the duty of the timekeeper to keep an accurate account of the time contestant is consuming. Each timekeeper shall be provided with a stopwatch, and time shall be called for each contestant when the time limit is reached. A contestant shall not be disqualified if the contestant stops promptly when time is called.
 - Item 2) Provide one or three judges for each event, and give the judge or judges a written copy of the rules concerning the judging of that event as set out in section and item dealing with the particular event.
 - Item (3) Provide programs for each contestant so that they may know where and when to appear for a contest.
- Sec. 2. In all State Literary Contests in which there are more than two contestants, a rating system of judging will be used so that conference of judges to determine winners may be eliminated.
- Sec. 3. Each contest shall be judged on merit according to points set out as essential for judging that contest. The age or sizes of the contestant shall have no influence in reaching a decision.
- Sec. 4. The presiding official in any contest will not by word of mouth, gesture, or any other change of expression, or in any other manner indicate approval or disapproval of the manner in which a contestant presents material.
- Sec. 5. All mistakes due to error of arithmetic or made contrary to the rules of the contest, and discovered before or after the decision of the judges, shall be corrected. In the use of score sheets for judge there shall be no column in which the judges may thaulate for judge there shall be no column in which the judges may tabulate

Item (1) DECLAMATION

Declamation is a contest for boys. It is a contest of delivery. It should be an oration worthy of a high school boy. The subject matter of the declamation should be serious in tune and delivered for the purpose of informing, convincing, and persuading the audience. All purely funny pieces, dramatic readings, and impersenations are barred from consideration. No accessories such as costumes or music will be allowed. The judges will take into consideration the following: (1) sincerity, (2) earnestness, (3) force, (4) voice, (5) polish, (6) grace, and (7) effectiveness of delivery.

The declamation shall not be over six minutes in length. The judges shall select a first, second, third, and fourth place winner.

Item (2) READING

Selections for this contest shall be taken from the works of the following authors:

William Cullen Bryant Henry Wadsworth Longfellow Sidney Lanier Robert Frost.

Reading is a contest for girls. Each contestant shall be given her selection at the State or District meet and shall be given 30 minutes to study the selection and then be required to read the selection before an audience. The judges shall select a first, second, third, and fourth place winner.

Item (3) PIANO

Each contestant will be allowed ten minutes in which to play two selections. Each contestant must play:

- Any short composition of HAYDN or MOZART or BEE-THOVEN
- (2) Any ONE selection from the following:

 SCHUBERT—Impromptu in B flat

 MENDELSSOHN—Etude in B flat minor

 SCHUMANN—Grillen (Whims from Fantasie Pieces)

 GRIEG—Wedding Day at Troldhaugen

 NIEMANN—Water Music

 IBERT—White Donkey

The judges will take into consideration the following: (1) accuracy of text; (2) musicianship; (3) interpretation; (4) rhythm; (5) phrasing; (6) shading; (7) dynamics, and (8) position while playing.

The judges shall select a first, second, third, and fourth place winner.

Item (4) ONE-ACT PLAY.

Each district shall hold elimination contests on or before the District Meet, the winning play of which shall be entered in the State Meet. No more than eight persons may be used in the cast, although parts may be doubled. Plays with immoral subjects will receive no consideration by the judges. The District Secretary must file an official entry for the play winning the District first place with the State Secretary at the same time he makes his report to the State Secretary for winners of the District Meet. Failure to do this will disqualify the district from competition in this event. No play shall be more than 30 minutes in length.

The judges shall select a first, second, third, and fourth place winner.

The scoring of points shall be twelve points first place, nine points second place, six points third place, and three points fourth place.

Plays winning first place in each group at the State Meet are eliminated in both groups for a period of two years. The following plays are barred for the current year in District and State Meets:

"PRELUDE TO DARKNESS"
"MOONCALF MUGFORDS"

"JACOB COMES HOME"
"THE SEVERED CHORD"

Item (5) ESSAY CONTEST, To BOYS and GIRLS

(a) Subject and Contestants: The State President shall select five subjects from current topics discussed in newspapers and magazines as the basis for the Essay Contest

The subjects must be sent in a sealed envelope to the District Secretary, said seal to be broken in the presence of the contestants after having assembled in the room for the contest. The contentants must receive no coaching during the contest.

The contestants, one boy and one girl from each school, may write upon any one of the five subjects selected, an essay not exceeding 600 words. The essay shall be written in ink. Two hours will be given for writing the essay.

(b) How judged: Verbal and grammatical correctness, spelling, and punctuation shall be considered of less importance than the interest and general effectiveness of the whole composition, but should have weight. The essay shall be judged by the thought, the

order, arrangement, and by the elements of style. It is a ready writer's contest and evidence of pre-memorized compositions shall weigh heavily against the contestants,. Boys' and Girls' essays will be graded separately and separate awards will be given. The judges shall select a first, second, third, and fourth place winner.

(s) Essays Sent: The first place essays in each district shall be sent by the District Secretary just as handed to the Committee of the District contest, with the name on a separate sheet, to the State Secretary at the same time he makes his report to the State Secretary for the winners of the District meet. The District winners in the Essay do not come to the State Meet for further contests. The State winners are determined from the winning papers sent in from each district.

Item (6) SPELLING

- (a) The State Secretary, on or about the first day of April each year shall send, securely sealed, to the District Secretary as many lists of words as the District may have schools entering the contest. The list will consist of 100 words to be spelled by the senior class of said schools on the first Wednesday in April. A minimum of 80 per cent of the words will be selected from the spellers on the State Textbook list; the remaining words will be selected from current news publications.
- (b) How conducted; The District Executive Committee shall appoint for each contesting school a visiting examiner to conduct the contest in each school, said examiner being a superintendent (or his representative) of some member school. The District Secretary shall send by registered mail to each representative examiner at post office where the said examiner is to go, the sealed list of words, with the instructions on the envelope: "To be held until called for." The visiting examiner is directed to select two assistants from the faculty in the school where the examination is being held to assist him in the conduct of the examination. The local spelling teacher may give out the words to the class. Definitions of words may be given.

The examiner shall make a written report of the result of the examination, signed by all members of the committee. It shall be sealed and mailed to District Secretary on the same day on which the examination is held with all of the examination papers of the class, together with such written explanation of absences as may be submitted to him. No excuse for absence other than a doctor's certificate will be accepted, except in the case of extraordinary providential hinderance, such as death in the family or some similar circumstances. One hundred words must be counted off for each unexcused absentee.

The District Secretary must notify the State Secretary by Monday of the last week in March what schools in the district will enter the spelling contests. Every examination not held according to these rules and regulations will be thrown out.

- (c) Winning papers: The District Committee may review the list sent in. The District Secretary shall send to the State Secretary the averages of all schools in his district and the papers of the winning schools. The District or State Secretary shall from these data award first, second, third, and fourth places according as to whether it is a District or State Contest.
- (d) All Spelling papers must be written in ink. One hundred errors must be counted off for each paper not written in ink.

In correcting papers count as errors the following:

- 1. All words so poorly written you cannot read them.
- 2. All words written over as "i" over and "e".
- 3. All words which show erasures and/or changes.
- 4. All words erased and/or crossed out and rewritten.
- All words which are not numbered to agree with the number of the word as given out by the examiner.
- 6. All words omitted.

Item (7) DEBATE

Each school must notify the Secretary of the District Committee not later than February 25th of its intention to enter the debates for the current year. The District Secretary shall group the school entering according to geographical arrangements or conditions of highways connecting the schools by March 10th and notify each school entering concerning the groupings. Each school so grouped shall present two teams of debaters, one team on the affirmative and one team on the negative, the affirmative team debating at home and the negative team away from home. Where schools drop out consolidations are to be made by the District Secretaries, and schools must be ready to meet any assigned contestants on the final date. Should all schools but one in a circle fail to debate, that school shall be declared the winner and be entitled to represent the school at the District Meet. If only two schools remain, these debate on the dual plan, each school sendnig a negative team to the other school. stood at the act of each agent and this will confidence with

Any school entering debate and dropping out without giving three days notice to the District Secretary shall not be allowed to enter any other literary event that year.

(a) Order of speeches: At all contests, time and order of Speeches shall be as follows:

MAIN SPEECHES

First affirmative speaker10	minutes
First negative speaker10	minutes
Second affirmative speaker10	minutes
Second negative speaker10	minutes

PREPARATION OF REBUTTAL

Time for preparation of rebuttal shall be given. The maximum time shall be limited to ten minutes. By unanimous consent of all participants in the debate, less time for preparation of rebuttal may be used and the debate continued.

REBUTTAL SPEECHES

First negative speaker4	minutes
First affirmative speaker4	minutes
Second negative speaker4	minutes
Second affirmative speaker4	minutes

Speakers on respective sides must speak in the same order in rebuttal as in main speech.

- (b) For 1945-46 the debate subject will be:
 - "Resolved: That every able bodied Male Citizen of the United States should have one year Full Time Military Training Before Attaining Age 24."
- (c) Judging and Scording: In every debate there shall be three judges. A copy of the instructions as given below shall be given to each judge. In selecting the winners each decision shall count 1, and the vote of each judge shall count 1, a perfect score making 8 points. All of the preliminary debates in the several districts shall be held the fourth Friday in March, at such hour as may be agreed upon, and in case of a tie, the tie must be settled by the following Friday. Both teams of the winning school in each circle will be entitled to contest at the District Meet, and the school scoring the most points will be declared the winner. Should there be a tie in points scored by each school at the District Meet, it shall be decided by lot which school shall represent the District at the State Meet. Each school winning in the District shall send two teams, one affirmative and one negative to the State Meet.
- (d) Instructions to Judges: A copy of the following instructions shall be given to each of the three judges: "The judges, who shall sit apart during the debate, shall judge the contest as a debate

voting without consultation 'Affirmative' or 'Negative' on the merits of the debate irrespective of their individual opinions as to the merits of the question. In deciding which team has done the most effective debating the judges shall take into consideration:

- Argument, by which is meant the substance and value of the proof offered and its skilful use in the discussion, and not the mere number of points.
- Rebuttal, by which is meant impromptu argument used to refute the direct argument on the opposing side as made. New evidence may be submitted, but new argument is forbidden. A marked difference in the style of rebuttal speeche and those of direct argument is a sign of poor preparation.
- Effectiveness, by which is meant the combination of good English with pleasing delivery.
- 4. In case of doubt, argument shall be stressed relatively more than delivery and rebuttal work more than main speeches, consideration being given to the directness of the rebuttal and the non-use of manuscripts. At the close of the debate each judge shall indicate his choice by ballot and deliver it to the presiding officer. In district debates the presiding officer shall inspect the ballots in the presence of a representative of each school and announce the result. In the State Meet the ballots in each individual debate shall be placed in a properly marked envelope by the presiding officer, shall be sealed, and delivered to the Chairman in charge of the State Meet Debates. After all of the debate envelopes have been turned in to the Chairman, he shall in the presence of one representative from each of the contesting schools, open the envelopes, read aloud the ballots, make an official tabulation of the results, and announce the results."
- (e) No Visiting: It shall be considered dishonorable for pupils, teachers or followers of one school to visit the debaters of another school for the purpose of securing information when the two schools are likely to meet on the same question.
- (f) Coaching: Coaching is necessary, but does not mean writing speeches. Coaching should be limited to (a) instruction in the are of debating in general; (b) help in the collection of material bearing on the subject; (c) advice, suggestion, direction, criticism, outline, and English as in regular class work; (d) drill on delivery. The coaching must be done by a teacher of the school and not by outside parties. Each school will observe these general principles of honest for the sake of the pupils.

At least three days before the debate the coach of each team shall sign and send to the principal of the opposing high school the following statement: "I hereby certify that to the best of my knowledge the preparation of the argument for this debate has been the work of the members of my team who will participate."

- (g) In all contests the debaters shall be separated from the audience and shall receive no coaching while the debate is in progress.
- (h) Teams: The teams constituting the debating team from a given school may not change from one team to another or change from negative to affirmative, or vice versa, in order to give the school a stronger representation on that side of the debate. Each school must be represented by the same debatosr or an alternate at the District or State Meet, that represented the school for the first circle debate and on the same side of the question that they originally represented.
- (i) At the State Meet, the Debate Committee shall arrange the district winners into the circles of five or less in each circle in the respective class, these to be designated as Circle 1 and Circle 2. The wining school in Circle 1 shall meet the winning school in Circle 2 for the State Championship. In the case of a tie between schools in the same circle before the circle winner is determined, the schools tied shall debate off the tie, each school furnishing two teams. Both teams of the winning school in each circle will be entitled to contest in the final debate, and the school scoring the most points shall be declared the winner. Should there be a tie in points scored in the final debate, a co-championship will be declared.

Item (8) QUARTET

In both District and State Meets each quartet will be limited to six minutes. Not more than three selections may be presented by each quartet. A quartet may be composed of male, female, or mixed voices. Quartet may be with or without accompanist. The judges shall select a first, second, third, and fourth place winner.

Item (9) TYPING

Typing will be a contest limited to pupils who are enrolled in their first year of typing. Any pupil who has had any instruction in typing prior to the beginning of the school year shall not be eligible. Either a boy or girl may represent a school. This will be a straight copy contest in speed and accuracy and will be graded on the basis of International Typing Rules. Each contestant will be required to type for a period of fifteen minutes. Each contestant will be given the same copy to transcribe.

First place winners from each district will complete at the State Meet. Each contestant is responsible for furnishing the typewriter which is to be used in the contest.

The judges will select a first, second, third, and fourth place winner.

Item (10) VOCAL SOLO

In both District and State Meets there will be a contest in vocal solo for boys and a contest in vocal solo for girls. Each contestant will be limited to five minutes. Not more than three selections may be presented by each contestant. Vocal solo may be given with or without accompainst. The judges shall select a first, second, third, and fourth place winner.

Item (11) HOME ECONOMICS

The Home Economics contest for the District and State Meets will be conducted according to the outline as given below:

Area of Home Economics: Foods

Subject: Green and Yellow Vegetables (Group I of the "Basic 7" Food). Selection, storage, preparation and serving of raw and cooked green and yellow vegetables.

Various methods of cooking green and yellow vegetables. Planning of daily diet to include green and yellow vegetables.

Contest at District and State Level: Contestants will be given the opportunity to show evidences of their understanding of the subject and of the skills involved by preparing one or more of the vegetables listed below, and by taking a written test.

Contests will be given a dinner menu which will include the green and/or yellow vegetables they will be expected to prepare. No recipes will be given since only common methods of vegetable cookery will be included and general principles of vegetable cookery may be applied. Contestants will be given time to make a plan of work to include the recipe to be used and the time budget to be followed.

Item (12) SHORTHAND

The contest in shorthand in District and State Meets will consist of dictation and transcription. Contestants will be expected to furnish own typewriter to use in transcribing the material dictated.

Judges will select a first, second, third, and fourth place winner. First place winners from each district will compete at the State meet.

Sec. 7. POINTS TOWARDS WINNING LITERARY CUP

- (a) The winners in declamation, reading, boys' essay, girls' essay, piano, home economic, quartet, typing, boys' vocal solo, girls' vocal solo, shorthand, and spelling shall receive seven points for first place, five points for second place, three points for third place, and one point for fourth place towards winning the literary cup in both District and State Meets.
- (b) The winner of the dual debate at the District or State Meet shall receive ten points and the loser shall receive six points towards winning the literary cup. Each school not going to the finals in the District shall receive points up to five according to the number of points received in the preliminary contest in debate. Each school not going to the finals in the State Meet shall receive points up to five, according to the number of points received in the circle debates.

(c) One-Act Plays at the District or State Meet shall receive twelve points for first place, nine points for second place, six points for third place, and three points for fourth place.

Sec. 8. NUMBER OF REPRESENTATIVES

- (a) A student may represent his or her school in not more than two events in which he or she performs alone. Pupils are not limited to the number of group events that they may enter.
- (b) Each school may have only one contestant in each of the following: Declamation, reading, piano, home economics, girls' essay, boys' essay, typing, boys' vocal solo, girls' vocal solo, and shorthand.

Sec. 9. TIES

In case of a tie for 1st place in any district literary event, except debate, the contest must be continued or reheld until a representative for the State Meet is determined. In case of a tie in the first contest the points shall be equally divided between the tied contestants. The continued or reheld contest shall carry no points, but is held merely to determine the representative of the District at the State Meet.

Sec. 10.

Score sheets used in the State Meet in the various contests will be turned in to the chairman in charge of the contest. The chairman will place these score sheets in a properly marked envelope, seal, and turn in to office.

The envelopes containing the score sheets will be opened in the office in the presence of one faculty representative from each school in the contest, the results tabulated, and the winners announced.
