May 2016 Study Guide

Okay, lets get to April 2016 Study Guide answers. Some of you had concerns about my math on question 7 but I ran it by several smarter guys and they all checked it out. Even ran it by George Demetriou, editor of the Reddings Guide, and he concurred. April 2016 answers:

- 1. D. The kick went out of bounds untouched by R. The apparent touch by R70 is ignored as it was forced. Multiple options exist.
- 2. B Referee
- 3. C Remember this is a fifteen (15) yard penalty
- 4. E C and D are true. Complex play. Obviously A and B false.
- 5. A True
- 6. B K is guilty of free kick out of bounds untouched by R. The kick is out of bounds because it touched a player out of bounds.
- 7. A Many emailed to complain about this one. I initially was concerned about my math but double checked it. Reddings editor George Demetriou confirmed the math and agreed that A is the only FALSE answer.
- 8. A True. The ball has touched the ground.
- 9. A True. This is a fifteen yard penalty.
- 10. A True.

OPINION PLAY:

96.4% had this as a touchback. 0.001% had a penalty on the play and A ball at the B two yard line. ?? Penalty?? Rest had safety. This play is directly from Reddings 2015 NFHS Guide, page 131, example 8. Here, Mr. Demetriou has this play as a SAFETY and it caught my attention. My thinking this was a touchback- forced touching, etc. After several emails he has changed his answer but not due to forced touching. Obviously the initial force of the fumble by A has been spent. Applying the rules of physics, not football, the action that took the ball into the end zone was the action by B91. But, according to rules of football, a new force CANNOT come from a block. This would still be a touchback even if B91 had blocked his on player into the ball. Review 8-5-1 on force creation. Blocks are not mentioned.

- 13. Defensive back B15 and receiver A7 both simultaneously catch a legal forward pass at the back of the end zone. B15 lands on the end line and A7 lands in the end zone. Both maintain possession falling to the ground. This is an incomplete pass.

- 14. Team A breaks the huddle and is in formation when it is observed two running backs both have number 24. This does not become a foul until a legal snap and the down is in progress.

- 15. Team A head coach may use an I- pad in a team conference outside the nine yard markers.

- 16. Which statement is FALSE concerning the free blocking zone:
 - A. An offensive lineman must be on the line of scrimmage at the snap and in the free blocking zone to be eligible to block below the waist.
 - B. In order for a block below the waist to be legal both the blocker and the player being blocked must be on the line of scrimmage and both the players and the ball be in the free blocking zone.
 - C. Wing back A12 goes in motion and is in the free blocking zone at the snap. Quarterback A10 is under center.Immediately at the snap A12 blocks B67 who is on the line of scrimmage and in the free blocking zone in the back.

- 17. R25 muffs a free kick at the R10 yard line. R25 picks up the ball at the R1 yard line and momentum takes him into the end zone where he is tackled by K65.

There is an inadvertent whistle after the fumble while the ball is loose with B recovering the fumble after the whistle. Regardless of acceptance or declining of the penalty Team A will next snap the ball.
