

Reclassification Process Still Far From Finish Line

The Georgia High School Association's Executive Committee approved a reclassification plan for its 451 member schools on Monday, August 17, 2015 at its regularly scheduled meeting in Macon. The Committee's action puts in place the frame work for distribution of schools for the next four years (2016-2020). Here are the basic components of the plan:

- Seven classifications, with a public / private split (for playoffs) in the smallest division.
- There would be eight championships in the "power ranked" sports of football, softball, basketball and baseball.
- The number of championships in other sports and activities would be decided by the GHSA office.
- The classification made up of the largest schools would contain approximately 44 schools (about 10% of the membership).
- A threshold for out-of-county students was established at 3%. Schools with a larger percentage of out-of-county students would be required to move up one classification.



- Schools in the "middle 5 classes" would be separated using a percentage of 19% 21% for each classification.
- If schools are moved up because of the out-of-county threshold, smaller schools in that classification would be given the opportunity to move down.

Historically the Reclassification plan involves a series of steps in order to reach the final ratification in January. Here is how the process should progress:

- Private schools turn in their enrollment figures on September 15.
- Public schools' and charter schools' FTE counts collected from the Department of Education (late October).
- All schools ranked by FTE, enrollments and/or out-of-county thresholds. Schools will then have an opportunity to appeal their enrollment or FTE numbers.
- The individual classifications will be designated and schools will have the opportunity to opt to play up in classification.
- Region assignments will be made. Schools will have an opportunity to appeal the assignment and ask for lateral transfers within that classification.
- The Reclassification Committee will vote on the plan after all appeals have been heard and settled.
- The full Executive Committee will hear appeals from schools still not satisfied with their region assignment.
- The final plan its ratified by the Executive Committee.

Schools then meet (January, 2016) to organize their new regions and create athletics schedules for 2016-18.

September is GHSA's Cancer Awareness Month

The GHSA is designating three consecutive weeks during the fall sports season to advance the awareness of and help fight several types of cancer.

In observance of Breast Cancer awareness, the GHSA will allow member schools to wear "Pink" uniforms at their HOME events during the week of September 7-14 for all fall

September 14-19 will be the first ever GHSA "Gold Week" to help raise the awareness of Childhood Cancer. Again, this will be for all fall sports.

And, finally, September 21-26 will be the second annual "Blue Week" in the sport of Football only to help fight Prostate Cancer. Special blue decals and blue wristbands can be worn this week, and the officials will have blue penalty flags to throw. Also the host school can stencil blue ribbons on the playing field for this special contest.

If a school does NOT have a home contest during one of the designated cancer awareness weeks, that school may request to wear or display the special cancer-awareness colors at a home contest during another week in September. Schools should contact the appropriate GHSA sports coordinator with this request.

GHSA Honors 2015 Cooperative Spirit Award Winning Schools



MINUTES

The semiannual meeting of the State Executive Committee of the Georgia High School Association was called to order at 9:00 a.m., on August 17, 2015, at the Macon Marriott City Center in Macon, Georgia, by Glenn White, President. COMMITTEE REPORTS

(NOTE: Proposals passed will go into effect for the 2016-17 school year unless specified to be "effective immediately.")

BOARD OF TRUSTEES

Report presented by Jesse Crews

The Committee recommended:

Proposal to restructure By-Law 1.47 as follows: A student's gender is determined by the gender noted on his/her birth certificate. Girls may participate on boys' teams when there is no girls' team offered in that sport by the school. Boys are not allowed to play on girls' teams even when there is no corresponding boys' sport.

MOTION PASSED (unanimously)

Proposal to add new A.(5)(3) under Football - State Playoffs on page 73 that reads: Certified staff members who work at the participating high schools only will be allowed free admission through the semifinal round with proper identification.

MOTION PASSED (56-1; Voting No: Arnold)

Accepting the Audit Report for 2014-15.

MOTION PASSED (unanimously)

The committee denied:

Proposal to reword By-Law 2.62 (E-6) to allow Tennis to play exhibition matches that are not counted.

BASEBALL COMMITTEE

Report presented by David Brooks

The committee recommended:

Proposal to re-consider holding state championships at neutral site(s) beginning with the 2017 season.

MOTION PASSED (45-12; Voting No: Crews, Arnold, Pollock, Pinson, Arasi, Fields, Lancaster, Maynard, May, Mobley, Giddens and Thompson)

The committee **denied**:

Proposal to change Baseball by-laws for 2015-16 to add a "Halted Game" rule.

The committee received as information:

Proposal to increase the number of games allowed from 26 to 30 on 26 play dates.

(NOTE: The committee directs the GHSA office to study the issue of finding a common number of contests for both softball and baseball.)

ELIGIBILITY COMMITTEE

Report presented by Pat Blenke

The committee recommended:

Proposal to delete wording: "residence" in by-law 1.62(a-4) and add wording "service area."

MOTION PASSED (unanimously)

Proposal to restructure by-law 1.62 (c) as follows:

- (c) The student was enrolled in a non-member private school in Georgia or was boarded at a school out of state and, without a bona fide move, transferred to a GHSA member school that serves his area of residence as long as:
 - 1. It is the initial move of the student from a non-member school to a member school serving his area of residence, AND
 - 2. The student was enrolled at the high school serving his area of residence in grades 9-12 before attending the non-member school, OR
 - 3. The student has not yet established eligibility at grades 9-12 at a member school serving his area of residence.

NOTE: Rules about joint custody transfers have control over the one time transfer restriction in this by-law.

GYMNASTICS COMMITTEE

Report presented by Lucia Norwood

The committee recommended:

Proposal to raise the qualifying requirements for teams and individuals for the Preliminary Meet (page 77, item B): Minimum scores must be earned during the regular season meets to qualify for the Preliminary Meet as follows:

- 1. Any team that scores 100.00 or better in two (2) regular season meets will automatically qualify.
- 2. An all-around score of 34.0 or better in three (3) regular season meets will qualify a gymnast.
- 3. An individual score of 8.50 or better in three (3) regular season meets will qualify a gymnast.

Proposal to delete "no-touch" warm-up rule (page 77, G).

RECLASSIFICATION COMMITTEE

Report presented by Earl Etheridge and Dave Hunter

The committee **recommended**:

Proposal for structure of classifications for 2016-18 school years as follows:

- A. Non-football playing schools will not be counted when calculating the teams being placed in Class A (they will be placed in their appropriate regions later).
- B. Classifications will be divided as follows:
 - 1. Big 44 (top 10% approximately) (NOTE: Teams may opt to play up into the Big 44 class, but no team may move down).
 - 2. Class A Public/Private (same as before except the number of playoff teams will increase from 16 public and 16 private to 24 public and 24 private in football, softball, basketball and baseball. The Public/Private school shall be allowed to play up in classification if they elect to do so. And if a school chooses to do so, then an equal number of Class AA schools will be given the option to move down to the Class A Public/Private class.
 - 3. There will be five (5) other classes, which will be split at the natural breaks between 19-21% of the remaining number after Big 44 and Class A Public/Private have been set.
- C. Attendance Zone Restriction
 - Schools accepting students from outside of their reclassification attendance zone may be subject to (over)

being placed in the next highest classification. If the percentage of students attending a school from outside that's school's reclassification attendance zone exceeds three (3%) percent of that school's F.T.E. Count, then that school shall be placed in the next highest classification. Schools may opt to be placed in the Big 44. However, the attendance zone restriction in this section will not be applied so to move a school up to the Big 44.

- 2. The reclassification attendance zone for ALL GHSA member schools shall be the county in which the school is located.
- 3. If a school is located in two counties, the school will be required to elect one of those to be it's Reclassification Attendance Zone. The election shall be binding for the entire reclassification period.
- 4. Any school(s) that feel(s) that their placement is unfair and unjustified will be allowed to appeal to the Reclassification Committee. The school will present data and evidence to the committee that proves the placement is not warranted or fair to the school and the program. If the committee feels that the placement of the school into a higher classification is not warranted, then the school would be placed in a classification based on the F.T.E. count without any regard to the percentage of out-of-county students.
- 5. The number of students determined by multiplier will not be rounded up. Example: If a multiplier allows for 9.82 students outside of the attendance zone, 9 students will be the number that is used.
- 6. If a school is found to be intentionally reporting incorrect numbers, that school will be banned from participating in state playoff games for two (2) years and must pay a fine of \$2,500.
- D. For regions that have fewer than five (5) teams, the number of teams going to the state playoffs will be one (1) fewer than the number of teams in the region. Example: A region with four teams would get three playoff spots. The available playoff slot(s) will be awarded to non-playoff team(s) with the highest power ranking.

Proposal to reword Article III, Section 2 (Item B) of Constitution to read as follows: B. Member schools will be realigned every four (4) years. Adjustments will be made at the end of two years according to updated FTE figures and the attendance zone restriction of 3% will be recalculated. (**NOTE: This is a constitutional change and requires two votes**).

TENNIS COMMITTEE

Report presented by Don Corr

The committee received as information:

Proposal to change Tennis from a Spring sport to a Fall sport starting in the fall of 2016, and to allow a spring tryout period similar to softball and volleyball. NOTE: The committee directed the GHSA office to survey the member schools about this issue and report the results at the next State Executive Committee meeting on Reclassification.

OLD BUSINESS

Proposal to delete Constitutional Reference: Section 5, D. 1. (Page 10) **SECOND VOTE**

"The Executive Director shall have the discretion upon receiving an application by a member school to set aside the effect of any academic eligibility or eight semester rule upon individual students when in the judgement of the Executive Director, the following criteria are met: ...
