#### NEW BUSINESS:

1. The full committee voted on the Board of Trustees' recommendations for the two female "at large" members of the incoming State Executive Committee as outlined in Section 2, Item "A" on page 8 of the GHSA Constitution. Those selections were chosen from region nominations at the Spring meeting of the SEC on June 23 and were **Michelle Masters** and **Regina Montgomery**.

#### DIRECTOR'S REPORT

Executive Director Robin Hines welcomed the new members of the committee and introduced the GHSA staff to them, explaining what each person's duties were, including newest Associate Director Tanya Anderson.

Hines then mentioned that the GHSA would be hosting the annual NFHS Section III meeting this September in Savannah.

He gave a brief legal update, mentioning two pending cases. And he went on to tell the committee that the GHSA office is in excellent financial shape despite losing the spring sports season to the pandemic.

Hines then went over the budget for 2020-21, telling the committee that it was the first time in GHSA history that a budget had actually gone down from the previous year.

Motion by Jewell, second by Simpson, to approve the 2020-21 budget as presented (see next page). MOTION PASSED (unanimously)

Hines closed by telling the committee about a possible new agreement with GoFan that would include incentives for schools that go cashless with their ticket sales.
