State Representative Will Wade addressed the committee with some concerns about the use of the power ranking system in classes A through 3A and not in classes 4A through 6A. He said that several schools in his district were concerned that deserving teams in the lower three classes might be left out of the playoffs with a power ranking system. He suggested that, if the power rating system was good for A-3A, it should be used in all classes.

The committee then discussed the pros and cons of the power ranking plan for Classes A through 3A. Several spoke of the possibility that not counting games against out-of-state or out-of-class teams will increase travel. The feeling was that schools will have to travel to find enough teams to play in their own respective classification.

The committee seemed to agree that teams should get credit for playing teams in higher classifications, and a proposal addressing that issue is expected to be presented at the next meeting on the Reclassification Committee.

That next meeting will be **9:00 a.m., on Thursday, November 16** in the GHSA office when schools will be allowed to appeal for **lateral transfers** within their classification.

The deadline to get on the agenda for the lateral appeal meeting is noon on Wednesday, November 15. The form to request a lateral transfer may be found on the "Forms Page" of the GHSA web site.
