

# **'Success' Not Always Measured in Wins and Losses**

Having access to a dictionary used to resolve questions (and arguments) about the proper definition of terms. Now, however, the reliance on the spoken word over the written word has produced multiple, subjective definitions to words and phrases that individuals or groups choose to use.

One word that is subject to multiple definitions is the word "SUCCESS." In every area of life, merchandise is advertised that will make people successful – usually promising less work to reach that success than ever before. Additional confusion arises when people discover that what they need to do (or to buy) to be successful depends on whose definition of success is being used. There are lots of definitions out there.

WHAT DOES IT TAKE FOR A HIGH SCHOOL TO HAVE A SUCCESSFUL ATH-LETIC PROGRAM? Very common answers involve such things as wins and losses, championships, state and national rankings, or players getting college scholarships. While the answers listed above draw a lot of attention from the media, parents, and the general public, educators need to look more deeply for answers.



Here is a list of questions that school administrators might use as a checklist for establishing a working definition for success in high school athletics.

- Are practice sessions good examples of a teaching/learning experience?
- Are students with all ranges of playing ability given the opportunity to develop their talents?
- Are students taught things that go beyond "Xs and Os" into lifelong learning, such as a strong work ethic and a willingness to work with other to reach a goal?
- Are students treated with respect and is respect demanded from the students toward teammates, opponents, and authority figures?
- Are students encouraged to find an area of participation in competitive activities in order to grow as a person and to have fun?
- Are athletes reminded regularly of the need to achieve academically?
- Are students reminded regularly of the need for good sporting behavior, and do coaches and administrators model such behavior?

While this is not an exhaustive list, if a school is able to answer affirmatively to these questions, that school will have a successful program. The success may not always be seen on the scoreboard, but it will be evident in the lives of the young people who go through our schools and into the communities across our nation.

Several weeks ago, two marvelous events occurred in Georgia. At the State Swimming and Diving Championships, 1,351 students participated in four days of competition at Westminster School. At the State Traditional (Individual) Wrestling Tournament, 1,456 wrestlers competed over three days on 12 mats at the Arena at Gwinnett Center. The vast majority of these students did not become a State Champion in their event(s), but they certainly demonstrated that they were "successful" in every sense of the word.

The sites have been determined for the Sectional rounds of the upcoming 2006 State Tennis Tournament.


The complete brackets for the State Tennis Tournament can be found on Page 163 of the GHSA Constitution & By-Laws book.
