**GHSA Office Report**

**Effect of 1.60 new Transfer by-law 1.60 implemented August 1, 2025**

Dr. Scott discussed the new transfer rule with the committee. The rule is designed to make sure students are not only moving for athletic purposes. The GHSA is an education-based organization. When a student has multiple transfers over a 4-year period it is not what is best for their education. Students are allowed to enter any school they wish as a freshman and make one bona fide move or transfer, after the first move or transfer the student must submit a hardship to show the move is not for athletic purposes. All moves or transfers are appealable.

**New regions**

The process for reclassification was explained to the committee. The reclassification committee began meeting January of 2025 discussing different opportunities to reclassify schools and did vote to keep the process the same using the school's FTE count. This process was presented to the 68-member Executive Committee for approval.

**Committee looking at public / private schools for placement in state playoffs**

The Executive Committee asked the Executive Director to put a committee together of private and public schools to discuss how the Post Season Ranking formula would affect their region and hosting home field. This committee will meet and work on language in the by-laws that both private and public school can agree on. This will need to be approved at the April Executive Committee meeting.

### **GHSA Foundation, Inc.**

Dr. Hines discussed with the committee the GHSA starting a foundation GHSA Foundation, Inc. This foundation will provide scholarships to member school students for post-secondary education. The GHSA Foundation, Inc. will be overseen by a seven-member Board of Directors. The Board will include three former members of the Executive Committee, three former or current high school educators or athletic department employees, and one former or current member of the Georgia legislature. At no time may any active member of the GHSA Executive Committee serve as a Director on the Foundation Board.
