

RECLASSIFICATION PROPOSAL 2016-17

- ISSUES THAT NEED ADDRESSING
- TRYING TO HELP THE LARGER 5A-6A SCHOOLS WITH DESCREPNICY IN NUMBERS AND TRAVEL.
- SMALLER DESCREPNICY IN NUMBERS FOR ALL CLASSIFICATIONS.
- ADDRESSING ADVANTAGES THAT PRIVATE SCHOOLS HAVE OVER PUBLIC SCHOOLS.
- WE HAVE SEPERATED CLASS A PRIVATE SCHOOLS. IT IS A GROWING PROBLEM IN AA, AND WILL ONLY BE A PROBLEM FOR OTHER CLASSIFICATIONS IF PRIVATE SCHOOLS ARE ASKED TO PLAY UP!
- ADDRESSING THE ADVANTAGES THAT METROPOLITAN SCHOOL SYSTEMS HAVE OVER RURAL SCHOOL SYSTEMS.

RECLASSIFICATION PROPOSAL

2016-17

- ALL SCHOOLS THAT DO NOT PLAY FOOTBALL WILL BE OMITTED FROM THE EQUATION. THEY WILL BE PLACED IN THEIR APPROPRIATE REGION ONCE NUMBERS ARE DETERMINED.

RECLASSIFICATION PROPOSAL

2016-17

- **UNDER THIS PLAN THERE WOULD BE 5 SEPARATE PUBLIC SCHOOL CLASSIFICATIONS, WITH 6 SEPARATE STATE CHAMPIONS.**

RECLASSIFICATION PROPOSAL 2016-17

- 5A CLASSIFICATION – 1501- UP
- ROUGHLY 124 SCHOOLS WOULD FALL INTO THIS CATEGORY.
- PLAY REGION SCHEDULE WITH 12 REGION CHAMPIONS.
- DIVIDE SCHOOLS ONCE PLAYOFFS BEGIN.
- SCHOOLS THAT HAVE 2000 STUDENTS OR MORE WILL SEPARATE INTO SUPER CLASS. THE TOP 32 BASED ON A POWER RANKING SYSTEM WOULD BE IN THE PLAYOFFS.(44 SCHOOLS ARE IN THIS GROUP)
- SCHOOLS WITH 1999 – 1501 STUDENTS (498 DIFFERENCE). WOULD PLAY FOR A SEPARATE STATE CHAMPIONSHIP. TOP 32 WOULD BE SELECTED THROUGH A POWER RANKING SYSTEM.(80 SCHOOLS IN THIS GROUP)

RECLASSIFICATION PROPOSAL 2016-17

- 4A CLASSIFICATION – ROUGHLY 76 SCHOOLS (8 REGIONS)
 - 1500 -1130 (370 DIFFERENCE)
- 3A CLASSIFICATION – ROUGHLY 64 SCHOOLS (8 REGIONS)
 - 1129 – 866 (263 DIFFERENCE)
- 2A CLASSIFICATION – ROUGHLY 65 SCHOOLS (8 REGIONS)
 - 865 – 526 (339 DIFFERENCE)
- 1A CLASSIFICATION – ROUGHLY 53 SCHOOLS (8 REGIONS)
 - 525-130 (395 DIFFERENCE)

RECLASSIFICATION PROPOSAL 2016-17

- PRIVATE SCHOOLS –ROUGHLY 55 SCHOOLS (45 PLAY FOOTBALL)
- PRIVATE SCHOOLS WOULD BE PLACED INTO 5 REGIONS
- PLAY REGION SCHEDULE WITH 5 REGION CHAMPIONS.
- DIVIDE FOR PLAYOFFS.
- UPPER DIVISION WOULD BE 401 AND UP. (17 SCHOOLS)
- LOWER DIVISION WOULD BE 400 AND DOWN.(28 SCHOOLS)
- POWER RANKINGS WOULD BE USED TO DETERMINE PLAYOFF TEAMS. TOP 16 TEAMS IN EACH DIVISION WOULD GO TO THE PLAYOFFS.

RECLASSIFICATION PROPOSAL 2016-17

- ISOLATION POLICY – DEALING WITH TRAVEL
- PRIVATE SCHOOLS THAT CANNOT FILL THEIR NONREGION SCHEDULE WOULD BE ALLOWED TO PLAY CROSSOVER GAMES WITH ANY GHSA REGION THAT IS IN CLOSE PROXIMITY OF THEIR SCHOOL. (The region that is chosen must comply.)

RECLASSIFICATION PROPOSAL 2016-17

- **MULTIPLIER – DEALING WITH STUDENTS ATTENDING SCHOOLS OUTSIDE OF THEIR SERVICE AREA.**
- **ONLY PUBLIC SCHOOLS WOULD BE GIVEN A 1.5 MULTIPLIER FOR ALL STUDENTS THAT ARE OUTSIDE OF THE ATTENDED SCHOOLS SERVICE AREA.**
