## **Georgia High School Association Region/Area Instructions**

### **One-Act Play**

The 7A thru AA classifications are regionalized events. Class A is an Area Event with schools divided into Public School Areas and Private School Areas. A Coordinator should be selected by the schools in each Area to oversee the events in Class A. Each school in the Area should be assessed equally for the expenses of the Areas in Class A.

Region/Area One Act Play must be completed no later than October 27, 2018. Winners should be submitted to the GHSA Office as soon as determined and no later than October 29, 2018. State One Act Play will be held on November 3rd (A-Private, A-Public, 4A, 6A) and November 10<sup>th</sup> (2A, 3A, 5A, 7A)

A Notification of Entry Form is supplied to all GHSA member schools by the GHSA Office. The schools are to complete and mail to their Region Secretary.

A Score Sheet is included in your notebook. Please make necessary copies for use at your Region/Area competition. A "Judges Work Copy" form is also included – an optional form that may assist judges with their rankings of the plays.

Sites for Region/Area Meet must be set. Select a Meet Director and/or Judges.

If admission is charged, a Region/Area Financial Form must be submitted, along with 5% of gate receipts, to the GHSA Office within 10 days of the event.

Region/Area Winners must be submitted to the GHSA Office on the appropriate form by the deadline date.

If someone other than the Region Secretary is in charge of this event, make sure that person is aware that Region/Area winners must be submitted to the GHSA Office by the deadline date.

A GHSA One Act Play Adjudication Director has been named – Dean Slusser from Camden County High School, who is establishing a training program for One Act Play Judges. He will be able to help you secure judges for your Region/Area Competition. His email is: dslusser@camden.k12.ga.us
