### **APPEALS**

#### 1. Gordon Lee

The appeal was submitted for an inaccurate calculation of their point total. After recalculating their schedule an adjustment was made from 18.12 to 18.19.

## 2. King's Ridge

The appeal was submitted on the basis that Mount de Sales had been given credit for wins against schools playing a non-region schedule (Twiggs Co. and Wilkinson Co.). MDS was not given credit for wins against Twiggs Co., and Wilkinson Co. did play a region schedule. MDS points were adjusted from 6.88 to 6.79.

### 3. Mount Vernon

The appeal was submitted on the basis that their point total is incorrect. After recalculating the points their revised power ranking total is 7.82.
