  - 1. The 1<sup>st</sup> place team in each area, plus the 2<sup>nd</sup> place team with the best overall record, will receive 1<sup>st</sup> round byes
  - 2. The remaining (8) teams will be seeded in the bracket based on area seeding
- Areas 4, 5, 6, will be bracketed in one sectional tournament, site TBD
  - 1. The 1<sup>st</sup> place team in each area, plus the 2<sup>nd</sup> place team with the best overall record, will receive 1<sup>st</sup> round byes
  - 2. The remaining (8) teams will be seeded in the bracket based on area seeding

B. The top (4) teams from each Sectional Tournament to advance to the Elite Eight Championship to be held April 22 & 23 at Twin Creeks Complex, Woodstock.
