

GHSA WRESTLING @ THE MACON COLISEUM

INFORMATION FOR PARENTS, WORKERS, & PATRONS/EVENT ATTENDEES

✦ **PATRONS SHOULD PURCHASE TICKETS ON GOFAN.CO BEFORE ARRIVING AT THE MACON COLISEUM. PLEASE MAKE SURE YOUR TICKETS ARE PURCHASED & PULLED UP ON YOUR PHONE SCREEN BEFORE GETTING IN THE ENTRANCE LINES.**

✦ **PATRONS/ATTENDEES/PARENTS ARE NOT PERMITTED TO BRING ANY FOOD & BEVERAGE ITEMS INTO THE MACON COLISEUM AT ANY TIME.**

- Concessions stands will be open with a variety of meals, snacks, and beverages.
- Food & beverage items for wrestlers will only be permitted to be brought in by the wrestlers when they first enter the venue for check-in, so please make sure they have what they need before leaving home.

✦ **AS PER GHSA RULES, ATTENDEES ARE NOT PERMITTED TO BRING ANY SIGNAGE INTO THE MACON COLISEUM FOR THIS YEAR'S TOURNAMENT.**

✦ **UPON ENTRANCE, ALL PATRONS WILL BE SUBJECT TO A SECURITY SCREENING WITH A HANDHELD METAL DETECTION WAND.**

- Please see below for information about our clear bag policy and requirements.

✦ **THE MACON COLISEUM HAS A "CLEAR BAG POLICY" FOR ALL PUBLIC EVENTS.**

- Each patron is limited to:

- * One (1) fully transparent **CLEAR BAG** with maximum dimensions of 12" long x 12" wide x 6" deep;
- AND
- * One (1) small handheld clutch or zipped wallet which is no larger than 8.5" long x 5.5" wide x 2" deep.

- **ALL OTHER BAGS** are PROHIBITED.

Patrons cannot bring in purses, diaper bags, backpacks, fanny packs, camera bags, grocery bags, or any other bags that do not fit the specifications described on this handout.

The graphic on the right also includes examples of permitted & prohibited bags.

- Please do not attempt to carry non-clear bags inside of your clear bag.
- Patrons with bags that do not fit the specifications on this handout will not be permitted to enter the venue.

The Macon Coliseum & GHSA are not liable for personal property left outside the venue or in vehicles.

CLEAR BAG POLICY

ALL PATRONS ARE LIMITED TO ONE (1) 12" X 12" X 6" CLEAR BAG AND NO LARGER THAN ONE (1) 8.5" X 5.5" HANDHELD CLUTCH. BAGS THAT DO NOT FIT THOSE DESCRIPTIONS WILL NOT BE ALLOWED IN THE VENUE.

PERMITTED BAGS:

12"X12"X6" CLEAR BAG (OR SMALLER) 1-GALLON PLASTIC FREEZER BAG (OR SMALLER) CLUTCH WITH SHOULDER STRAP CLUTCH WITH WRIST STRAP

PROHIBITED BAGS INCLUDE, BUT ARE NOT LIMITED TO:

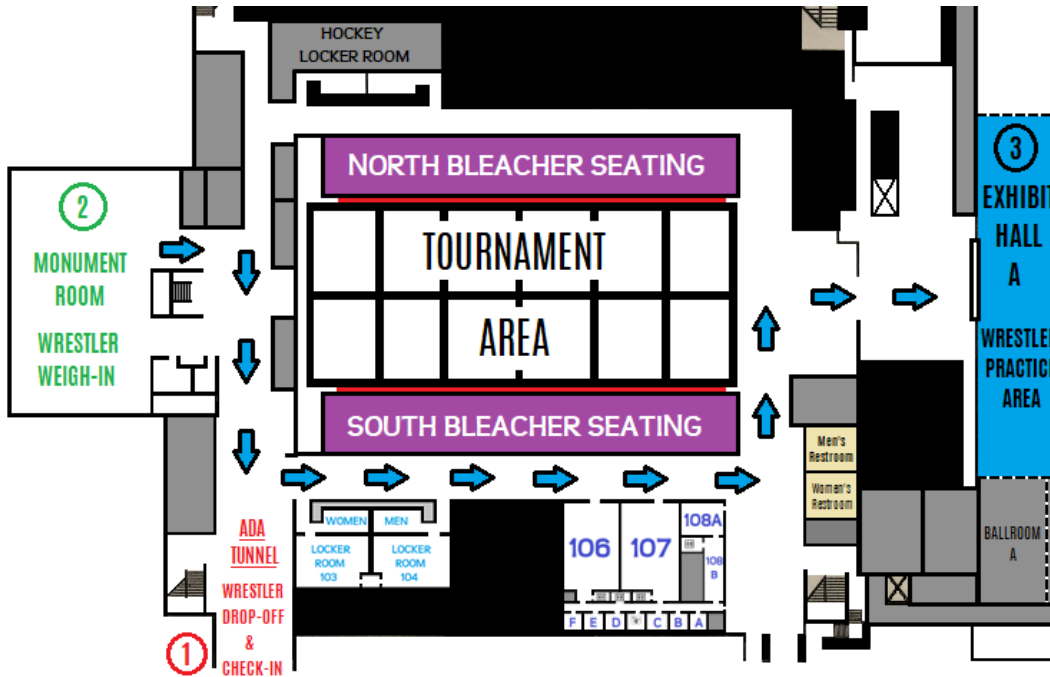
BACKPACK PURSE CAMERA BAG BINOCULARS CASE

FANNY PACK DIAPER BAG PATTERNED CLEAR BAG

INFORMATION FOR WRESTLERS & COACHING STAFF

✦ COMPETING WRESTLERS WILL NOT BE PERMITTED TO GO INTO THE FAN/SPECTATOR SEATING AREAS OR BLEACHERS AT ANY TIME DURING THE STATE CHAMPIONSHIP.

✦ COMPETING WRESTLERS WILL BE LIMITED TO CERTAIN AREAS.



1. **CHECK-IN:** Upon arrival, wrestlers should be dropped off at the Macon Coliseum ADA Tunnel (#1 on the diagram above) with all team gear. Wrestlers, coaching staff, & team personnel should check in directly inside the ADA tunnel doors.
 2. **WEIGH-IN:** After checking in, wrestlers & coaches should then proceed to the Monument Room (#2 on the diagram above) for weigh-ins.
 3. **HOLDING AREA:** After weighing in, wrestlers must take all gear, food, & coolers to the Wrestler Practice Area in the Convention Center Exhibit Hall A (#3 on the diagram above) by walking down the lower level locker room hallway. This path is shown on the diagram with blue arrows.
- * **IMPORTANT:** Wrestlers who are participating in the tournament are **REQUIRED** to stay in the Exhibit Hall at all times until their matches.
DO NOT CROWD NEAR THE FLOOR OR BIKE RACK AT ANY TIME.
 - * The Exhibit Hall is the only place that coolers/food will be permitted.
 - * After their match, wrestlers must go back into the Exhibit Hall practice area until they are ready to leave for the day.

NOTE: WRESTLERS WHO ARE NOT COMPETING MUST PURCHASE A TICKET ON GOFAN AND ENTER THROUGH THE FRONT DOORS.
